

Manitoba Supplemental Game Conditions Sports Betting & Pools

PlayNow Sports Betting Game Conditions and PlayNow Pools Game Conditions from the British Columbia Lottery Corporation ("BCLC") Apply

- 1. These Game Conditions are supplemental to the following:
 - a. BCLC PlayNow Sports Betting Game Conditions, and
 - b. BCLC PlayNow Pools Game Conditions and apply to wagers, bets, cards purchased in Manitoba on PlayNow.com.
- 2. If there is any conflict between these Game Conditions and the Game Conditions noted in item 1, the applicable Game Conditions noted in item 1 will prevail.

Definitions

Defined terms have the same meaning as defined in the BCLC PlayNow Sports Betting Game Conditions and/or the BCLC PlayNow Pools Game Conditions, except for the following:

"Calendar Day" means the 24-hour period measured from 2:00:00 am CT until 1:59:59 am CT on the following calendar date;

"Internet Gaming System" means the computer systems utilized by MBLL for the operation of games on PlayNow.com, including but not limited to the BCLC internet gaming system and any other computer systems managed by BCLC and/or Authorized Suppliers under the authority of MBLL:

"MBLL" means Manitoba Liquor and Lotteries Corporation;

"PlayNow Sports Bet" or "PlayNow Sports Betting" means 'lottery schemes' within the meaning of the Criminal Code (Canada) offered by MBLL through PlayNow.com under the heading of "Sports" and conducted, managed and operated by the government of Manitoba through MBLL, either alone or in cooperation with its Authorized Suppliers;

"Resettlement" or "Resettle" means a change to a Settlement made by MBLL and/or its Authorized Suppliers;

"Result" means the outcome of a Selection at the time of Settlement as determined by MBLL and/or its Authorized Suppliers;

"Sports Betting Conditions" means the instructions, information, prize entitlements, descriptions, explanations, guides or qualifications established by MBLL and/or its Authorized Suppliers and applicable to PlayNow Sports Betting, including those set out in this document, set out at Schedule B to the BCLC PlayNow Sports Betting Game Conditions, and those in a related description of the Market on PlayNow.com; and

"Ticket" means a ticket, certificate, or other instrument (including an electronic transaction) authorized for sale by MBLL and is not cancelled or void. In the case of the BCLC PlayNow Sports Betting Game Conditions and BCLC PlayNow Pools Game Conditions, "Ticket" is used synonymously with "Bet" as defined in the PlayNow.com Player Agreement.

In addition, the following additional definition is applicable:

- "Authorized Suppliers" means BCLC, and any other gaming entities that supply services and equipment related to PlayNow.com;
- 4. References within Game Conditions
 All references to "British Columbia Lottery Corporation," "The Corporation" and "BCLC" within the
 BCLC PlayNow Sports Betting Game Conditions and the BCLC PlayNow Pools Game Conditions
 are understood to mean "BCLC as authorized by MBLL."

5. Role of BCLC

As outlined in the PlayNow.com Player Agreement, the services of MBLL's online gambling are provided by Authorized Suppliers, including BCLC. The Games offered for play are compliant lottery schemes under the Criminal Code of Canada. MBLL has the right at any time and in its sole and absolute discretion to, without notice, discontinue or limit the sale of Games through PlayNow.com or to modify the manner in which it sells Games.

6. Issuance of Tickets and Cards

In Manitoba, Tickets and pool Cards can also be purchased on PlayNow.com by any eligible person upon payment to Manitoba Liquor & Lotteries Corporation (MBLL).

7. Cancellation of Ticket

Once you have purchased a Ticket or Card, you may not cancel it.

Prize Claims

For PlayNow.com prizes, prizes must be claimed in the manner set forth in the Player Agreement. Prizes are paid by MBLL and/or its Authorized Suppliers.

9. PlayNow.com's Rights to Amend or Cancel

PlayNow.com and/or MBLL reserve the right at all times to amend or cancel the number of selection(s) available to be purchased on the same ticket or the number and types of wagers available to be purchased on the same Ticket or Card; or to change the method by which a Ticket or Card is issued to a person.
