Event Period

- This event runs from 06:00:00 am CT June 14, 2018 until half-time during the last Winnipeg Blue Bombers game of the 2018 CFL Season. The exact time at half-time is based on gameplay but is estimated to be 75-90 minutes following kickoff.
- If the Winnipeg Blue Bombers reach the 2018 CFL Semi-Final on November 11, 2018, the 2018 CFL Final on November 18, 2018, and/or the 2018 Grey Cup Championship on November 25, 2018, this event will be extended to include those game dates. Otherwise, this event will end at half-time during the November 3, 2018 game.

Qualified Entrant

A qualified entrant ("Entrant") is:

- a Manitoba resident, 18 years of age or older with an open PlayNow.com account, except Manitoba Liquor and Lotteries Corporation ("MBLL") employees, as well as their immediate family members, defined as father, mother, brother, sister, spouse (including common-law), child of the employee.
- Individuals who have self-excluded or who self-exclude during the Event Period from PlayNow.com
 or from a BCLC or MBLL gaming facility are not Entrants and are not eligible to enter this event or
 win a prize.

- Contest periods 19, 20 and 21 will be available only if the Winnipeg Blue Bombers play a game on the specified date.
- A maximum of one (1) CTW per player can be earned during each of the contest periods.
- Only wagers relating to a specific game are eligible to earn a CTW during the contest period that
 relates to that game. For example, only wagers relating to the July 7, 2018 game are eligible to be
 included in the CTW calculation for contest period 4.
- A bet that earns a CTW must include at least one of the eligible events for a specified game date
 in order to be considered eligible. For example, a player who parlays one eligible event per game
 for games on July 7, 2018 and July 14, 2018, would be eligible for up to one (1) CTW in each of
 contest periods 4 and 5, provided all other conditions are met.

Prize Draws

- All eligible CTWs from a given contest period will be entered into a random draw for the chance

 CTWs will be complied by BCLC and provided to BCLC Corporate Security & Compliance for
 the purpose of conducting the draw.
- All draws will be held on the stated date, or as soon as practical thereafter.
- A draw will be conducted on each date specified at approximately 2:00:00pm CT or as soon as practical thereafter. One (1) winner will be selected from all eligible CTWs for the corresponding contest period.
- Upon a CTW being drawn (a "Drawn CTW"), BCLC and MBLL will certify that the Drawn CTW and corresponding Entrant are qualified to win. If BCLC and MBLL are unable to certify that the Drawn CTW and corresponding Entrant are qualified to win, that Drawn CTW will be disqualified and another CTW will be drawn. This process will continue until a winner has been declared.
