

### Definitions

**BCLC** means British Columbia Lottery Corporation.

**MBLL** means Manitoba Liquor and Lotteries Corporation.

**SaskGaming** means Saskatchewan Gaming Corporation.

**SIGA** means Saskatchewan Indian Gaming Authority.

**Casino Rebate Token** means the amount of your Overall Loss during a Promotional Period awarded to you in the form of a PlayNow.com free play token.

**Eligible Casino Games** means any PlayNow.com casino games, excluding Live Casino.

**Eligible Participant(s)** means:

- A British Columbia resident, nineteen (19) years of age or older
- A Manitoba resident, eighteen (18) years of age or older
- A Saskatchewan resident, nineteen (19) years of age or older.

**Held Funds** means the account where a player's winnings from a Token with a wagering requirement in progress are held.

**Overall Loss** means the value of your wager(s) on Eligible Casino Games during a Promotional Period exceed the value of your winnings at the End Date/Time during the same Promotional Period.

**Promotional Period** means the dates set out in the table below on page 2.

**Wagering Requirement** means the minimum dollar value on Eligible Games a player must spend before they are eligible to withdraw their winnings generated from Tokens.

### Rebate Conditions

1. To receive your Casino Rebate Token, you must complete the following steps:
  - a. Login to your PlayNow.com account during a Promotional Period.
  - b. Enter the promo code **2023REBATE** in the promo code section of your My Promotions page.
  - c. Play any Eligible Casino Games during the Promotional Period:
    - i. Instants, Slots, Tables and Video Poker
  - d. To receive a Casino Rebate Token, the value of your wager(s) on Eligible Casino Games during a Promotional Period must exceed the value of your winnings in an Overall Loss.  
**See Appendix 1 for examples of Overall Loss calculation.**
    - i. If a player uses tokens or Held Funds from previous promotions for their wager(s) for this promotion, losses on those wagers will not count towards the calculation of Overall Loss.
    - ii. If at the End Date/Time of each Promotional Period, a player's winnings exceeds or is equal to their wager(s) on Eligible Casino Games for that Promotional Period, they will not receive a Casino Rebate Token.



## 2023 Casino Rebate Conditions

- e. 10% of your Overall Loss will be awarded to you as a Casino Rebate Token up to a maximum value of \$250. Therefore, if 10% of your Overall Loss is an amount higher than \$250, you are only eligible to receive a \$250 Casino Rebate Token.
2. The Promotional Periods and the assigned promo code is defined below (promotions will not be honoured outside of the Promotional Period):

3. The Casino Rebate Token will be credited to your PlayNow.com account in the form of a casino token three to five business days following the End Date/Time of the Promotional Period.
4. Once credited to your account, the Casino Rebate Token must be used within 14 days after which it will expire. Casino Rebate Tokens will not be reissued following expiration.
5. Casino Rebate Tokens awarded through this promotion may only be used for Eligible Casino Games, subject to availability. See PlayNow.com/casino for game details.
6. All Casino Rebate Tokens awarded have a 30x wagering requirement applied to them.

### Wagering Requirement Rules

- a. The Wagering Requirement for this Promotion is 30 times the value of redeemed Tokens. You will meet the Wagering Requirement when the total dollar value of wagers made with the Token add up to 30 times the value of the Token.
  - i. For example, for a \$10 Token, the Wagering Requirement =  $\$10 \times 30 = \$300$  (\$10 Token + \$290 play through of winnings). The Wagering Requirement is met when a player wagers the \$10 Token and \$290 of winnings from that original Token on eligible games.
- b. Until the Wagering Requirement is met, any winnings generated from the Token will be deposited in your Held Funds account. You can play eligible games with Held Funds, but you cannot withdraw Held Funds from your account.
- c. Once the Wagering Requirement is met, any Held Funds remaining will be automatically transferred to your Cash Balance and can be withdrawn from your account or used on any game on PlayNow.com

12. All stated dollar amounts are in Canadian funds.

14. If validation of your PlayNow.com account is pending, the Casino Rebate Token will be deposited when the PlayNow.com account is validated after all conditions and requirements for a valid PlayNow.com account have been met.
15. If you are having difficulty entering the Promotion Code, you must call Customer Support with code error issues while the Promotion Code is still valid. Any inquiries after the promotion period has lapsed will not be considered as eligible for the Casino Rebate Token.

**APPENDIX 1**

Overall Loss calculation examples:

Example 1

<b>Eligible Casino Game #1</b>	
Wager	(\$50.00)
Winnings	\$10.00
Outcome	(\$40.00)
<b>Eligible Casino Game #2</b>	
Wager	(\$50.00)
Winnings	\$80.00
Outcome	\$30.00
<b>Eligible Casino Game #3</b>	
Wager	(\$50.00)
Winnings	\$120.00
Outcome	\$70.00

**Overall Outcome** \$60.00  
**10% of Outcome** \$6.00  
**Casino Token Amount** \$0.00

Example 2

<b>Eligible Casino Game #1</b>	
Wager	(\$1000.00)
Winnings	\$50.00
Outcome	(\$950.00)
<b>Eligible Casino Game #2</b>	
Wager	(\$1000.00)
Winnings	\$200.00
Outcome	(\$800.00)
<b>Eligible Casino Game #3</b>	
Wager	(\$1000.00)
Winnings	\$150.00
Outcome	(\$850.00)

**Overall Outcome** (\$2600.00)  
**10% of Outcome** \$260.00  
**Casino Token Amount** \$250.00

In Example 1, the player's winnings exceeded the player's wagers, so the player is not eligible for a Casino Rebate Token.

In Example 2, the player's wagers exceeded the player's winnings, but 10% of the Overall Loss is greater than \$250 ( $(\$2600.00) \times 10\% = \$260$ ), so the player is only eligible for a \$250 Casino Rebate Token.
