



Barnyard Bounty Free Play Conditions

Definitions

BCLC means British Columbia Lottery Corporation.

MBLL means Manitoba Liquor and Lotteries Corporation.

SaskGaming means Saskatchewan Gaming Corporation.

SIGA means Saskatchewan Indian Gaming Authority.

Casino Free Play means casino free play that may be used to wager on Eligible Games.

Eligible Games means:

- PlayNow.com casino slot games, subject to availability.

Eligible Participant(s) means:

- a British Columbia resident, nineteen (19) years of age or older with an active PlayNow.com account,
- a Manitoba resident, eighteen (18) years of age or older with an active PlayNow.com account, or
- a Saskatchewan resident, nineteen (19) years of age or older with an active PlayNow.com account

Held Funds means the account where a player's winnings from a Casino Free Play with a wagering requirement in progress are held.

Promotion Period means:

For British Columbia:

- The Promotion Period is from 00:00:00 am PT on Monday, May 12, 2025, to 23:59:59 pm PT on Sunday, June 8, 2025.

For Manitoba

- The Promotion Period is from 02:00:00 am CDT on Monday May 12, 2025, to 01:59:59 am CDT on Monday, June 9, 2025.

For Saskatchewan:

- The Promotion Period is from 01:00:00 am CST on Monday May 12, 2024, to 0:59:59 am CST on Monday, June 9, 2025.

Wagering Requirement means the minimum dollar value on Eligible Games a player must spend before they are eligible to withdraw their winnings generated from Casino Free Play

How to Receive Barnyard Bounty Casino Free Play

1. To receive a Casino Free Play under this Promotion, you must complete the following steps, in the following order:
 - a. Register for an account on PlayNow.com or log into your PlayNow.com account.
 - b. Enter the "**Promotion Code**" that corresponds to the applicable "**Validity Period**", as set out in the table below, and will be displayed in the "My Promotions" section of PlayNow.com.

There is a maximum of \$70 awarded in Casino Free Play during the Promotion Period.

2. Casino Free Play will be automatically awarded to your account.
 - a. A Promotion Code entered for a period before or after the applicable Validity Period will not be eligible for a Casino Free Play.
3. Each Promotion Code may only be redeemed once.
4. Once credited to your account, the Casino Free Play must be used within 7 days. Casino Free Plays will not be reissued following expiration.
5. Each Casino Free Play awarded from this Promotion has a 30x Wagering Requirement applied to them.

Wagering Requirement Rules

- a. The Wagering Requirement for each Casino Free Play is thirty (30) times the value of redeemed Casino Free Play. You will meet the Wagering Requirement when the total dollar value of wagers made with the Casino Free Play add up to thirty (30) times the value of the Casino Free Play .
 - i. For example, for a \$10 Casino Free Play, the Wagering Requirement = $\$10 \times 30 = \300 (\$10 Casino Free Play+ \$290 play through of winnings). The Wagering Requirement is met when a player wagers the \$10 Casino Free Play and \$290 of winnings from that original Casino Free Play on eligible games.
 - b. Until the Wagering Requirement is met, any winnings generated from the Casino Free Play will be deposited in your Held Funds account. You can play eligible games with Held Funds, but you cannot withdraw Held Funds from your account.
 - c. Once the Wagering Requirement is met, any Held Funds remaining will be automatically transferred to your Cash Balance and can be withdrawn from your account or used on any game on PlayNow.com

6. An Eligible Participant may receive a maximum of one (1) Casino Free Play under this promotion during each Validity Period.
 7. Casino Free Play awarded through this Promotion may only be used for wagering on Eligible Games.
 8. Wagers placed using a Casino Free Play do not qualify for any other promotion on PlayNow.com.
