

Definitions

BCLC means British Columbia Lottery Corporation.

MBLL means Manitoba Liquor and Lotteries Corporation.

SIGA means Saskatchewan Indian Gaming Authority.

Casino Bonus means either a casino slot free play or a Casino Rebate Token awarded to Eligible Participants under this promotion.

Casino Rebate Token means the PlayNow.com casino bonus awarded to Eligible Participants under this promotion and valid on any eligible Casino game on PlayNow.com, excluding Live Casino, Baccarat, and Roulette.

Eligible Games means the PlayNow.com casino slot games listed on playnow.com/battleofthegames landing page.

Eligible Participant(s) means:

For British Columbia:

- a British Columbia resident, nineteen (19) years of age or older with an active PlayNow.com account,

For Manitoba:

- a Manitoba resident, eighteen (18) years of age or older with an active PlayNow.com account,

For Saskatchewan:

- a Saskatchewan resident, nineteen (19) years of age or older with an active PlayNow.com account.
- provided that:
 - individuals who are currently self-excluded or who self-exclude at any time during the Promotional Period from PlayNow.com are not Eligible Participants and are not eligible to receive a Casino Bonus; and
 - individuals that are currently barred or are barred at any time during the Promotional Period from PlayNow.com, or a British Columbia, Manitoba, or Saskatchewan gaming facility, are not Eligible Participants and are not eligible to receive a Casino Bonus.

Unique Sessions means the number of unique players who wager on a Featured Game during a Promotional Period.

Versus Style Battle means the Featured Game with the most Unique Sessions during a Round Promotional Period that will be eligible for a Casino Bonus.

APPENDIX 1

If Total Wagers equal Total Winnings (net position = \$0), Eligible Participant is not eligible for a Casino Bonus.

If Total Winnings exceed Total Wagers (net position is positive), Eligible Participant is not eligible for a Casino Bonus.

If Total Wagers exceed Total Winnings (net position is negative), Eligible Participant's Casino Bonus will be calculated as 10% of the difference between Total Wagers and Total Winnings.

If Eligible Participant's calculated rebate amount is less than \$0.01, no Casino bonus will be issued.

Incomplete or stuck game transactions will not count toward the calculation.

Overall Net Loss calculation examples:

Casino Rebate Token Amount \$260.00

In Example 1, the Eligible Participant's winnings exceeded the Eligible Player's wagers, so the Eligible Participant is not eligible for a Casino Rebate Token.

In Example 2, the Eligible Participant's wagers exceeded the Eligible Participant's winnings. (\$2,600.00 x 10% = \$260), so the Eligible Participant is eligible for a \$260 Casino Rebate Token.
