



## Brighter Days to Play Casino Bonus Conditions

### Definitions

**BCLC** means British Columbia Lottery Corporation.

**MBLL** means Manitoba Liquor and Lotteries Corporation.

**SaskGaming** means Saskatchewan Gaming Corporation.

**SIGA** means Saskatchewan Indian Gaming Authority.

**Casino Bonus** means a casino bonus that may be used to wager on Eligible Games.

**Eligible Games** means the PlayNow games listed on the outline below, subject to availability.

**Held Funds** means the account where a player's winnings from a Casino Bonus with a wagering requirement in progress are held.

**Eligible Participant(s)** means:

- a British Columbia resident, nineteen (19) years of age or older with an active PlayNow.com account, who is not a:
  - BCLC employee; or
  - Family or household member of a BCLC employee,
- a Saskatchewan resident, nineteen (19) years of age or older with an active PlayNow.com account,
- a Manitoba resident, eighteen (18) years of age or older with an active PlayNow.com account,
- provided that:
  - individuals who are currently self-excluded or who self-exclude at any time during the Promotion Period from PlayNow.com are not Eligible Participants and are not eligible to receive a Casino Bonus; and
  - individuals that are currently barred or are barred at any time during the Promotion Period from PlayNow.com, or a British Columbia, Manitoba, or Saskatchewan gaming facility, are not Eligible Participants and are not eligible to receive a Casino Bonus.

**Promotion Period** means:

For British Columbia:

For Saskatchewan:

**Wagering Requirement** means the minimum dollar value on Eligible Games a player must spend before they are eligible to withdraw their winnings generated from a Casino Bonus.

1. To receive a Casino Bonus under this Promotion, you must complete the following steps, in the following order:
  - a. Register for an account on PlayNow.com or log into your PlayNow.com account.
  - b. Enter the “**Promotion Code**” that corresponds during the applicable “**Validity Period**”, as set out in the table below, in the “My Promotions” section of PlayNow.com.

- c. There is a maximum of \$25 awarded in Casino Bonuses.
    - d. A Promotion Code entered for a period before or after the Validity Period will not be eligible for a Casino Bonus.
2. Each Promotion Code may only be redeemed once.
3. Once credited to your account, the Casino Bonus must be used within twenty-four (24) hours. Casino Bonuses will not be reissued following expiration.
4. Each Casino Bonus awarded from this Promotion has a ten (10) times Wagering Requirement applied to them.

### Wagering Requirement Rules

- a. The Wagering Requirement for each Casino Bonus is ten (10) times the value of redeemed Casino Bonus. You will meet the Wagering Requirement when the total dollar value of wagers made with the Casino Bonus add up to ten (10) times the value of the Casino Bonus.

- b. Until the Wagering Requirement is met, any winnings generated from the Casino Bonus will be deposited in your Held Funds account. You can play Eligible Games with Held Funds, but you

- cannot withdraw Held Funds from your account.
  - c. Once the Wagering Requirement is met, any Held Funds remaining will be automatically transferred to your cash balance and can be withdrawn from your account or used on any game on PlayNow.com

5. See the PlayNow.com Player Agreement for terms and conditions applicable to Casino Bonuses.
  6. An Eligible Participant may receive a maximum of one (1) Casino Bonus during each Validity Period.
  7. Casino Bonuses awarded through this Promotion may only be used for wagering on Eligible Games.
  8. Wagers placed using a Casino Bonus do not qualify for any other promotion on PlayNow.com.
