Promotion Period

British Columbia (BC)

- The promotion period is from 00:00:00 am PT on Monday, March 20, 2023 to 23:59:59 pm PT on Sunday, April 16, 2023 (the “**Promotion Period**”).

Manitoba (MB)

- The promotion period is from 2:00:00 am CDT on Monday, March 20, 2023 to 1:59:59 am CDT on Monday, April 17, 2023 (the “**Promotion Period**”).

Saskatchewan (SK)

- The promotion period is from 1:00:00 am CST on Monday, March 20, 2023 to 0:59:59 am CST on Monday, April 17, 2023 (the “**Promotion Period**”).

Definitions

BCLC means British Columbia Lottery Corporation.

MBLL means Manitoba Liquor and Lotteries Corporation.

SaskGaming means Saskatchewan Gaming Corporation.

SIGA means Saskatchewan Indian Gaming Authority.

CTW(s) means chance(s) to win a prize.

Drawn Entrant means an individual whose name is drawn to win a prize as a result of the Prize Draw.

Gaming Day means the twenty-four (24) hour period from 12:00:00 am PT / 2:00:00am CDT on one day to 23:59:59 am PT / 01:59:59am CDT on the following day during the Promotion Period.

Grand Prize(s) means:

- In British Columbia, one (1) cash prize of \$10,000 CDN, to be deposited to the winner’s PlayNow Account.
- In Manitoba, ten (10) cash prizes of \$10,000 CDN, to be deposited to the winner’s PlayNow Account.
- In Saskatchewan, one (1) cash prize of \$50,000 CDN, to be deposited to the winner’s PlayNow Account.

Prize Winner(s) means the Drawn Entrant or Reserve Drawn Entrant who fulfills all of these Promotion conditions. Prize Winner(s) can win a maximum of one (1) Cash Prize, or one (1) Token Prize per Eligibility Period and one (1) Grand Prize throughout the Promotion Period.

Qualified Entrant(s) means:

- A British Columbia resident, nineteen (19) years of age or older with an open PlayNow.com account, who is not a:
 - BCLC employee; or

Provided that:

- Live Casino games are not eligible games.
- A Qualified Entrant only needs to enter the Promotion Code once in order to earn CTWs on PlayNow.com throughout the Promotion Period.

No purchase Necessary:

- Qualified Entrants may obtain three (3) (British Columbia and Manitoba) or two (2) (Saskatchewan) CTW by mailing an entry to British Columbia Lottery Corporation, 2940 Virtual Way, Vancouver, B.C., V5M 0A6, Attention: Marketing. The envelope must contain the entry, which must be on a single sheet of paper. The entry must contain the following information, which must be legible: name, mailing address with postal code, phone number and email address. A maximum of one (1) No-Purchase Necessary entry (consisting of two (2) or three (3) CTW, depending on jurisdiction, as set out above) may be submitted per person in this promotion. Any mailing containing more than one entry, including multiple mail-ins by the same person, will be discarded, including any otherwise valid entry. - If BCLC, or MBLL or SIGA in conjunction with BCLC, is unable to determine whether the Drawn Entrant is a Qualified Entrant, then the Drawn Entrant will be disqualified and a Reserve Drawn Entrant will replace the Drawn Entrant and, if qualified, become a Prize Winner.
