

Definitions

BCLC means British Columbia Lottery Corporation.

MBLL means Manitoba Liquor and Lotteries Corporation.

SIGA means Saskatchewan Indian Gaming Authority.

SaskGaming means Saskatchewan Gaming Corporation.

Drawn Entrant means an individual whose name is drawn to win a Prize as a result of the Prize Draw.

Winner(s) means the Drawn Entrant or Reserve Drawn Entrant who fulfills these Terms and Conditions.

Reserve Drawn Entrant means an individual whose name is drawn as a backup as a result of the Prize Draw and who becomes a Qualified Entrant in the event that the original Drawn Entrant becomes disqualified.

Eligible Game Category means one of Sports, Casino, Live Casino, and Lottery (where applicable). Poker and Bingo are excluded from Eligible Game Category.

Contest Day means the twenty-four-hour period from 0:00:00 am PT/2:00:00 am CT to 23:59:59 pm PT/1:59:59 am CT during the Contest Period in which a player may obtain the maximum number of Qualified Entries permitted in their province of residence, as outlined in these Terms and Conditions.

Prize means the prize awarded in this Contest, consisting of a trip for two (2) people to Italy, anchored in Milan, including round-trip economy airfare, hotel accommodations, ground transportation within Italy, and other elements as determined by BCLC, MBLL, or SIGA, in consultation with Flight Centre. Final trip details may vary based on the travel dates but must fall within the September–October 2026 travel window.

Contest Period

1. This contest (the “**Contest**”) runs from 00:00:00 AM PT on February 4, 2026, to 11:59:59 PM PT on February 22, 2026, in British Columbia, and from 02:00:00 AM CT on February 4, 2026, to 01:59:59 AM CT on February 23, 2026, in both Manitoba and Saskatchewan (the “**Contest Period**”) and will be subject to these Terms and Conditions (the “**Terms and Conditions**”).

Qualified Entrant

2. A qualified entrant (“**Qualified Entrant**”) means:
 - a) a British Columbia resident, 19 years of age or older with an active PlayNow.com account, who is not a:
 - BCLC employee; or
 - b) a Saskatchewan resident, 19 years of age or older with an active PlayNow.com account or;
 - c) a Manitoba resident 18 years of age or older with an active PlayNow.com account, who is not:
 - a MBLL employee;
 - an immediate family member of an MBLL employee, defined as father, mother, brother, sister, spouse (including common-law), child or ward of the employee;provided that:
 - individuals who are currently self-excluded or who self-exclude at any time during the Contest Period from PlayNow.com are not Qualified Entrants and are not eligible to win a Prize; and

- individuals that are currently barred or are barred at any time during the Contest Period from PlayNow.com, or a British Columbia, or Saskatchewan gaming facility, or individuals who self-excluded from a gaming facility operated by MBLL, are not Qualified Entrants and are not eligible to win a Prize.

How to Enter

3. There are three (3) ways to enter this Contest:
 - a. Obtain a “Qualified Entry” through PlayNow.com or;
 - b. Bonus entry via promo code, provided via social media communications;
 - c. Submit a No Purchase Necessary Entry

Qualified Entry

4. **On PlayNow.com:**
 - Qualified Entrant must sign up or log in to their PlayNow account and successfully enter promotion code “**MILAN**” (the “**Promotion Code**”) during the Contest Period into the MyPromotions section of their PlayNow.com account and;
 - Make a minimum \$5 wager on any Eligible Game Category during a Contest Day.
 - Qualified Entrants may receive up to the following number of Qualified Entries per Contest Day:
 - **British Columbia and Manitoba:** a maximum of **four (4)** Qualified Entries per Contest Day, one (1) per Eligible Game Category (Sports, Casino, Live Casino, and Lottery).
 - **Saskatchewan:** a maximum of **three (3)** Qualified Entries per Contest Day, one (1) per available Eligible Game Category (Sports, Casino, and Live Casino), as Lottery is not available in Saskatchewan.
 - Entry limits applicable to a specific jurisdiction apply only to the Draw for that jurisdiction and do not affect odds of winning in another province.”
 - **Qualified Entrants may receive a maximum number of Qualified Entries through PlayNow as follows:**
 - **British Columbia and Manitoba:** up to **seventy-six (76)** Qualified Entries during the Contest Period.
 - **Saskatchewan:** up to **fifty-seven (57)** Qualified Entries during the Contest Period, reflecting the maximum of three (3) Qualified Entries per Contest Day in Saskatchewan.
 - Jurisdiction-specific maximums apply only to each entrant’s province of residence.

No Purchase Necessary Entry

5. **No Purchase Necessary Mail-In:**
 - No purchase is necessary to enter this contest. To obtain a No Purchase Necessary Entry, a Qualified Entrant may obtain ten (10) Qualified Entries by mailing an entry to British Columbia Lottery Corporation, 2940 Virtual Way, Vancouver, B.C., V5M 0A6, Attention: Promotions, Escape to Milan Contest. The envelope must contain the entry, which must be on a single sheet of paper. The entry must contain the following information, which must be legible: full name, mailing address with postal code, phone number, and email address, and PlayNow ID;
 - Each Qualified Entrant may submit a maximum of one (1) No Purchase Necessary Entry.
 - All No Purchase Necessary Entries must be received by the end of the Contest Period.
 - An entry that is missing any of the details mentioned above and/or received after the end of the Contest Period will be disqualified and not entered into the draw.

Bonus Entries

6. **Bonus Entry from Social Gamified Activity**

- Players who correctly complete the designated social gamified activity and enter the exclusive bonus promotion code provided through PlayNow's official social media channels during the Contest Period will receive a bonus of one (1) entry into this Contest.
 - Bonus entries are awarded only once per player for the duration of the Contest Period.
7. **Bonus Entries from No Purchase Necessary Entries**
- Players who correctly submit one (1) No Purchase Necessary Entry prior to the end of the Contest Period will receive a one-time bonus of ten (10) entries.
 - Bonus entries are awarded in addition to the maximum number of Qualified Entries permitted under these Terms and Conditions.

The Prizes

8. There are a total of three (3) prizes (each a "Prize") available to be won in this Contest:
- a) In British Columbia, there is one (1) Prize available to be won, with a value of up to approximately \$15,000 CAD.
 - b) In Manitoba, there is one (1) Prize available to be won, with a value of up to approximately \$15,000 CAD.
 - c) In Saskatchewan, there is one (1) Prize available to be won, with a value of up to approximately \$15,000 CAD.
9. Each Winner will receive one (1) Trip to Italy for two (2) people, one of whom must be the Winner. The Trip is subject to availability and may be subject to change. Exact details, including travel dates and itinerary, will be confirmed by BCLC, MBLL, or SIGA (as applicable) and Flight Centre. Guests must meet all eligibility and documentation requirements.
10. The Prize will be awarded to each Winner via email with instructions about how to book with Flight Centre. Winners must book their Prize with Flight Centre before July 31, 2026.
11. **Prize Details** - Each Prize consists of a trip for two (2) people to Italy, anchored in Milan, and includes the following components:
- a. Round-trip economy airfare for two (2) from the Winner's province of residence to Milan, Italy, and return from Rome, Italy (including one checked bag per person; seat selection subject to airline policies and additional fees, if applicable).
 - b. Hotel accommodation for the Winner and their guest in Italy, including:
 - i. Three (3) nights in Milan; and
 - ii. Additional hotel accommodations in other Italian destinations, as determined by Flight Centre.
 - iii. Hotel accommodations will be provided on a standard double-occupancy basis and are subject to availability, as arranged by Flight Centre.
 - c. \$2,000 Travel Credit to be deposited into the winner's PlayNow account
 - d. Ground transportation within Italy, which may include airport transfers and inter-city train travel between destinations.
 - e. Private roundtrip transportation to the designated airport in the Winner's province of residence.
 - f. Curated travel experiences in Italy, which may include guided city tours, food tours, or other activities selected in consultation with Flight Centre.
 - g. Taxes and fees relating to the airfare, accommodation, ground transportation, and experiences booked as part of the Prize with Flight Centre.
 - h. Travel must occur within the September–October 2026 travel period.
 - i. Exact trip duration, itinerary, destinations, hotel arrangements, transportation, and experience selections will be determined by BCLC, MBLL, or SIGA (as applicable), in consultation with Flight Centre, and will vary based on travel date selection, availability, and Winner preferences.

- j. The Prize may include additional travel enhancements or credits, at the discretion of BCLC, MBLL, or SIGA (as applicable), in consultation with Flight Centre. Any such enhancements or credits are discretionary, subject to availability, and form part of the total Prize value.
- 12. The Winner and their guest are solely responsible for:
 - a. any additional expenses not included in or covered by the Prize, including but not limited to:
 - 1. any secondary, upgraded, or additional travel itinerary, experience or accommodations;
 - 2. food, drink, entertainment, and experience charges; and
 - 3. gratuities;
 - b. travel documentation, passport or visa fees, or travel authorization or other entry or documentation requirements;
 - c. travel vaccinations or medical consultations;
 - d. any expenses incurred by the Winner or their guest while they are partaking in the Prize (e.g. medical expenses, trip interruption or cancellation, lost or stolen items, missed flights/connections, cancellation fees, travel insurance, etc.).
- 13. Both the Winner and guest must adhere to all rules, regulations, and instructions provided by BCLC, MBLL, SIGA, and Flight Centre. Any misconduct may result in forfeiture of the Prize without compensation.
- 14. The odds of winning a Prize in a particular jurisdiction depends on the number of entries received in that jurisdiction.
- 15. The Prizes cannot be transferred without the consent of BCLC, or MBLL in conjunction with BCLC, or SIGA in conjunction with BCLC, which may be withheld for any reason.

A Winner who does not accept the Prize as awarded may, at the discretion of BCLC, or MBLL in conjunction with BCLC, or SIGA in conjunction with BCLC, be deemed to have refused the Prize. BCLC, MBLL in conjunction with BCLC, or SIGA in conjunction with BCLC, reserves the right to disqualify a Winner who does not accept the Prize as awarded and select another Drawn Entrant as the Winner.
- 17. By accepting the Prize, the Winner authorizes and agrees that their name and telephone number and/or email address will be provided to Flight Centre for the purpose of facilitating the Prize.
- 18. **WINNERS MUST BOOK TRAVEL WITH FLIGHT CENTRE WITHIN THIRTY (30) DAYS OF BEING AWARDED A PRIZE.**
 - a. Winners must complete all travel within three hundred and sixty-five (365) days of being awarded the Prize.
 - b. Travel is intended to occur within the September–October 2026 timeframe, subject to availability and confirmation by Flight Centre.
 - c. Failure to meet the booking or travel timing requirements will result in forfeiture of the Prize, with no compensation.
- 19. Winners must bring a guest who is over the age of majority in their place of residence. Guests are responsible for providing their own valid travel documents and/or insurance. Each Winner guest must agree to such representations, releases, waivers and indemnities as BCLC, MBLL in conjunction with BCLC or SIGA in conjunction with BCLC, may require.

The Draw

- 20. Qualified Entries received with respect to each province during the Contest Period are entered into a random draw for that province (the “**Prize Draw**”) to select one (1) Qualified Entrant and five (5) backups in British Columbia, one (1) Qualified Entrant and five (5) backups in Manitoba, and one (1) Qualified Entrant and five (5) backups in Saskatchewan to win a Prize (the “**Drawn Entrants**”). The Prize Draw will occur on February 26, 2026, or as soon as practical thereafter.
- 21. A BCLC representative will attempt to contact the Drawn Entrants by telephone and/or email using the contact information provided in their PlayNow.com profile within three (3) days of a Prize Draw. It is the responsibility of each Qualified Entrant to ensure that their PlayNow.com account has current

- information, including a current telephone number and email address at which they can be contacted.
22. Drawn Entrants will have three (3) days from the first contact attempt to respond and accept (by email or phone) the Prize before BCLC or MBLL in conjunction with BCLC, or SIGA in conjunction with BCLC, may, at its sole discretion, determine that the Prize is forfeited and a Reserve Drawn Entrant will replace the Drawn Entrant and, if qualified, become a Winner. In no event shall BCLC, MBLL, or SIGA be liable for a Qualified Entrant not receiving notification of the fact that their name has been drawn.
 23. If BCLC or MBLL in conjunction with BCLC, or SIGA in conjunction with BCLC, is unable to determine whether the Drawn Entrant is a Qualified Entrant, then the Drawn Entrant will be disqualified and a Reserve Drawn Entrant will replace the Drawn Entrant and, if qualified, become a Winner. This process will continue until the Prize has been awarded.
 24. In order to receive a Prize, the Winner must satisfy BCLC, or MBLL in conjunction with BCLC, or SIGA in conjunction with BCLC, that the Winner is entitled to receive a Prize in this Contest, correctly answer a time-limited skill-testing question, present government-issued photo identification that matches the name of the Winner, and agree to such representations, releases, waivers and indemnities as BCLC, or MBLL in conjunction with BCLC, or SIGA in conjunction with BCLC may require. BCLC, or MBLL in conjunction with BCLC, or SIGA in conjunction with BCLC has no obligation to deliver a Prize to a Winner who cannot satisfy these requirements.
 25. If a Drawn Entrant does not comply with these requirements, then they may, at the sole discretion of BCLC or MBLL in conjunction with BCLC, or SIGA in conjunction with BCLC, be deemed to have refused the Prize and a Reserve Drawn Entrant will replace the Drawn Entrant and, if qualified, become a Winner

General Conditions

26. BCLC, or MBLL in conjunction with BCLC, or SIGA in conjunction with BCLC may, at its sole discretion and without liability whatsoever, alter, amend, change, modify, this Contest at any time.
27. BCLC, or MBLL in conjunction with BCLC, or SIGA and SaskGaming in conjunction with BCLC, are not liable to any person for loss or damage to persons or property, related to or resulting from participation in this Contest, whether or not resulting from or connected with acts or omissions of BCLC, MBLL and SIGA or any participating gaming service providers.
28. BCLC, MBLL, and SIGA are not responsible for commencing, continuing or completing any event or awarding prizes in the event of circumstances beyond BCLC, MBLL, or SIGA's control.
29. By entering this Contest, each Winner agrees that BCLC, MBLL, or SIGA may publish or broadcast, in any medium without remuneration, consideration or compensation, the name, location and a recent image of each Winner, and that such image will be provided by each Winner to BCLC, MBLL, SIGA, or their agents, in electronic format upon BCLC, MBLL, or SIGA's request
30. BCLC, or MBLL in conjunction with BCLC, or SIGA in conjunction with BCLC, reserve the right to disqualify players that do not comply with these Terms and Conditions, the Player Agreement, or other applicable Rules or Terms of Use (each as defined in the Player Agreement, collectively the "**Lottery Rules**"). In the event of a conflict between these Terms and Conditions and any lottery scheme, the applicable Lottery Rules will prevail.
31. In making the Prizes available, BCLC, MBLL, and SIGA make no representations or warranties whatsoever, either expressed or implied, oral or written.
32. IN NO EVENT WILL BCLC, MBLL, SIGA, SASKGAMING, OR THEIR RESPECTIVE DIRECTORS, OFFICERS, EMPLOYEES, CONTRACTORS, AGENTS, REPRESENTATIVES OR AFFILIATES (TOGETHER, THE "**RELEASED PARTIES**") BE LIABLE FOR, AND EACH ENTRANT AND THEIR GUESTS HEREBY RELEASE THEM FROM, ANY DAMAGES, LOSSES OR OTHER AMOUNTS OF ANY KIND WHATSOEVER, WHETHER IN CONTRACT, TORT, OR OTHERWISE, ARISING FROM OR IN CONNECTION WITH THIS CONTEST OR A PRIZE.
