

Casino Matched Deposit Bonus Token Welcome Offer Conditions

- 1. To receive your 100% Matched Deposit Bonus Token ("Casino Token") you must complete these steps in order:
 - a. Register for an account on PlayNow.com (you must not have a preexisting Playnow.com account)
 - b. During registration, select the Matched Deposit Casino Offer and add the promo code **CA20MATCH** (the "**Promo Code**").
 - c. Make a minimum first-time deposit of \$10 into your account. Your Casino Token amount is based on your first deposit made after registering with the Promo Code, up to a maximum of \$20.
 - d. Spend 100% (cumulative) of your first deposit amount on any Casino Game (excluding Live Casino). For the Casino Token, the minimum spend amount is \$10, and the maximum spend amount is \$20.
 - e. If placing multiple wagers to qualify towards the Casino Token, wagers must be placed within the Promotion Period.
- Only new players who register for a PlayNow.com account for the first time, and who
 register with the Promo Code, are eligible to receive the Live Casino Token on their
 first deposit. Players who already have a PlayNow.com account at the time of this
 offer are not eligible to receive this offer.
- 3. Tokens cannot be used to meet the deposit or spend requirements outlined above.
- The Promo Code is valid from March 1, 2021 at 04:08:59 am PT / 06:08:59 am CT and will expire on March 31, 2022 at 04:08:59 am PT / 06:08:59 am CT ("Promotion Period").
- 5. The Casino Token offer is based on a player's first deposit after registering with the promo code and limited to one per player.
- 6. Once credited to your account, the Casino Token must be used within 14 days. Casino Tokens will not be reissued following expiration.
- 7. Casino Tokens awarded for this promotion have a maximum value of \$20.



8. Casino Tokens awarded have a 30x wagering requirement. Only Casino games (excluding Live Casino) will count towards the wagering requirements. Held funds generated from the Casino Token may only be used on Casino games (excluding Live Casino).

Wagering Requirement Rules

- a. A wagering requirement is a condition applied to a Token and affects how a player is able to spend the winnings generated by that promotion.
- b. A Casino Token awarded has a 30x wagering requirement:
 - i. Therefore, for a \$10 Casino Token, the wagering requirement = \$10 x 30 = \$300 (\$10 Token + \$290 play through of winnings)
- c. The wagering requirement is met when a player wagers the \$10 Casino Token and \$290 of winnings from that original Token on eligible games.
- d. Until the wagering requirement is met, any winnings generated from the Casino Token will be deposited in your Held Funds account. You can play eligible games with Held Funds but you cannot withdraw Held Funds from your account.
- e. Once the wagering requirement is met, any Held Funds remaining will be transferred to your Cash Balance and can be withdrawn from your account or used on any game on PlayNow.com,

- 9. Casino Tokens must be accepted as awarded and cannot be exchanged for cash. Tokens must be accepted as awarded.
- 10. British Columbia Lottery Corporation ("**BCLC**"), or Manitoba Liquor and Lotteries Corporation ("**MBLL**") in conjunction with BCLC, reserve the right, in their discretion, to adjust or cancel any Token for any reason including if awarded in error.
- 11. BCLC or MBLL in conjunction with BCLC reserve the right to disqualify entrants and/or entries that do not comply with these conditions, the Player Agreement, or other applicable Rules or Terms of Use (each as defined in the Player Agreement, collectively the "Lottery Rules"). In the event of a conflict between these conditions and any lottery scheme, the applicable Lottery Rules will prevail.

- 15. If validation of your PlayNow.com account is pending, the Casino Token will be deposited when the PlayNow.com account is validated providing all conditions have been met.
- 16. If you are having difficulty entering the promo code, you must contact Customer Support with code error issues while the promo is *still* valid. Any inquiries after the Promotion Period has lapsed will not be considered as eligible for the Casino Token.
- 17. All decisions of BCLC, or MBLL in conjunction with BCLC, are final and binding.
