

Definitions

"BCLC" means British Columbia Lottery Corporation.

"MBLL" means the Manitoba Liquor and Lotteries Corporation.

"SIGA" means the Saskatchewan Indian Gaming Authority.

"Eligible Games" means the PlayNow.com casino slot games listed on <u>www.playnow.com/level-up-leaderboard</u> landing page.

"Eligible Participant" means:

For British Columbia:

A British Columbia resident, nineteen (19) years of age or older, with an active PlayNow.com account.

For Manitoba:

A Manitoba resident, eighteen (18) years of age or older, with an active PlayNow.com account.

For Saskatchewan:

A Saskatchewan resident, nineteen (19) years of age or older, with an active PlayNow.com account.

"Promotion Period" means:

For British Columbia:

- Week One: Starts at 0:00:00 AM PT on Saturday, August 16, 2025, and will end on Sunday, August 17, 2025, at 23:59:59 PM PT.
- Week Two: Starts at 0:00:00 AM PT on Saturday, August 23, 2025, and will end on Sunday, August 24, 2025, at 23:59:59 PM PT.

For Saskatchewan:

- Week Two: Starts at 1:00:00 AM CT on Saturday, August 23, 2025, and will end on Monday, August 24, 2025, at 12:59:59 AM CT.

Week Three: Starts 1:00:00 AM CT on Sunday, August 31, 2025, and will end on Tuesday, September 2, 2025, at 12:59:59 AM CT.

"Leaderboard" means the rank of Eligible Participants in the event based on points calculated in accordance with the Win to Wager Ratio.





"Leaderboard Prize" means the cash jackpot prize awarded in this promotion based on Eligible Participants' rank on the Leaderboard.

• There are twenty (20) Leaderboard Prizes available to be won during each Promotion Period, for a total of sixty (60) Leaderboard Prizes.

Wager means the dollar value a player wagers on the Eligible Games.

Win means the dollar value of how much a player wins on the Eligible Games.

Win to Wager Ratio means the calculation of a player's win divided by their wager per spin. This value is then multiplied by one hundred (100), which is the total value of points that spin will earn the Eligible Participant

• Example: An Eligible Participant wagers \$2.00 on the Eligible Game. From this spin, they win \$4.00. \$4.00 divided by \$2.00 is 2, which is multiplied by 100 to get a total value of 200 points. The Eligible Participants score will increase by 200 points.

How to Participate

- 1. Log in to your PlayNow.com account on a compatible device during one of the Promotion Periods.
- 2. Launch any of the Eligible Games.
- 3. When the Leaderboard pop-up appears, select "Opt-In" to participate.
 - O Note: If you select "Opt-Out," you may not be eligible to participate in the tournament.
- 4. Begin your gameplay.
- 5. Your score will be calculated based on your Win-to-Wager Ratio.
 - Your score will be based on twenty (twenty) consecutive spins.
 - You will have three hundred (300) attempts to achieve your best score by clicking "retry" on the Leaderboard widget.
- 6. The Leaderboard widget will display to you your highest score based on all your attempts, and will display the ranking of the top twenty (20) players to all participants
- 7. At the end of each Promotion Period, prizes will be awarded to players based on the final ranking of the Leaderboard.

- 9. The total value of the Leaderboard Prizes is \$60,000.
- 10. The odds of winning a Leaderboard Prize depend on the number of Eligible Participants who participate. In the event of a tie, the player who first obtained the score will receive the higher position on the Leaderboard.
