



Definitions

“BCLC” means British Columbia Lottery Corporation.

“MBLL” means the Manitoba Liquor and Lotteries Corporation.

“SIGA” means the Saskatchewan Indian Gaming Authority.

“Eligible Games” means the PlayNow.com casino slot games listed on www.playnow.com/level-up-leaderboard landing page.

“Winner” means an Eligible Participant who meets all Conditions and is ranked in a prizing position on the Leaderboard at the end of a Promotion Period.

“Promotion” means the Level Up Leaderboard promotion described in these Conditions, consisting of four (4) tournaments offered during the Promotion Period.

“Eligible Participant” means:

- For British Columbia:
A British Columbia resident, who is nineteen (19) years of age or older, with an active PlayNow.com account.
- For Manitoba:
A Manitoba resident, who is eighteen (18) years of age or older, with an active PlayNow.com account.
- For Saskatchewan:
A Saskatchewan resident, who is nineteen (19) years of age or older, with an active PlayNow.com account.

“Promotion Period” means:

For British Columbia:

- **Tournament Four:** Starts at 00:00:00 AM PDT on Monday, June 1, 2026 and will end on Tuesday, June 2, 2026, at 23:59:59 PM PDT.

For Manitoba:

- **Tournament One:** Starts at 02:00:00 AM CDT on Wednesday, May 20, 2026, and will end on Friday, May 22, 2026, at 01:59:59 AM CDT.
- **Tournament Two:** Starts at 02:00:00 AM CDT on Tuesday, May 26, 2026 and will end on Thursday, May 28, 2026, at 01:59:59 AM CDT.
- **Tournament Three:** Starts 02:00:00 AM CDT on Thursday, May 28, 2026, and will end on Saturday, May 30, 2026, at 01:59:59 AM CDT.
- **Tournament Four:** Starts at 02:00:00 AM CDT on Monday, June 1, 2026 and will end on Wednesday, June 3, 2026, at 01:59:59 AM CDT.

For Saskatchewan:

- **Tournament One:** Starts at 01:00:00 AM CST on Wednesday, May 20, 2026, and will end on Friday, May 22, 2026, at 00:59:59 AM CST.
- **Tournament Two:** Starts at 01:00:00 AM CST on Tuesday, May 26, 2026 and will end on Thursday, May 28, 2026, at 00:59:59 AM CST.
- **Tournament Three:** Starts 01:00:00 AM CST on Thursday, May 28, 2026, and will end on Saturday, May 30, 2026, at 00:59:59 AM CST.
- **Tournament Four:** Starts at 01:00:00 AM CST on Monday, June 1, 2026 and will end on Wednesday, June 3, 2026, at 00:59:59 AM CST.

“**Leaderboard**” means the rank of Eligible Participants in the event based on points calculated in accordance with the Win to Wager Ratio.

“**Leaderboard Prize**” means the cash jackpot prize awarded in this promotion based on Eligible Participants’ rank on the Leaderboard.

- There are a total of sixty (60) Leaderboard Prizes available to be won with a grand total of \$60,000 in prizing.

Wager means the dollar value a player wagers on the Eligible Games.

Win means the dollar value of how much a player wins on the Eligible Games.

Win to Wager Ratio means the calculation of a player's win divided by their wager per spin. This value is then multiplied by one hundred (100), which is the total value of points that spin will earn the Eligible Participant

- Example: An Eligible Participant wagers \$2.00 on the Eligible Game. From this spin, they win \$4.00. \$4.00 divided by \$2.00 is 2, which is multiplied by 100 to get a total value of 200 points. The Eligible Participants score will increase by 200 points.

How to Participate

1. Log in to your PlayNow.com account on a compatible device during one of the Promotion Periods.
2. Launch any of the Eligible Games.
3. When the Leaderboard pop-up appears, select “Opt-In” to participate.
 - *Note: If you select “Opt-Out,” you may not be eligible to participate in the tournament.*
4. Begin your gameplay.
5. Your score will be calculated based on your **Win-to-Wager** Ratio.
 - Your score will be based on fifteen (15) consecutive spins.
 - You will have unlimited attempts to achieve your best score by clicking “retry” on the Leaderboard widget.
6. The Leaderboard widget will display to you your highest score based on all your attempts, and will display the ranking of the top players to all participants
7. At the end of each Promotion Period, prizes will be awarded to players based on the final ranking of the Leaderboard.
8. There are a total of sixty (60) Leaderboard Prizes to be awarded to sixty (60) winners (“Winner”). The value of each Leaderboard Prize is based on the rank in which a player finishes the tournament, as per the table below.

9. The total value of the Leaderboard Prizes is \$60,000.
10. The odds of winning a Leaderboard Prize depend on the number of Eligible Participants who participate. In the event of a tie, the player who first obtained the score will receive the higher position on the Leaderboard.
11. The Leaderboard will automatically calculate your total score based on fifteen (15) consecutive spins. Only spins in which a player wins will be counted towards their total score. Points will not be deducted from spins where players do not generate a win.
