

Definitions

BCLC means British Columbia Lottery Corporation.

MBLL means Manitoba Liquor and Lotteries Corporation.

Casino Free Play means a free play with a value of \$10, \$15 or \$50 awarded through this promotion that may be used to wager on Eligible Games on PlayNow.com.

Eligible Games means any PlayNow.com casino games (Instants, Slots, Tables, and Video Poker), excluding Live Casino.
