



# British Columbia Lottery Corporation “Year of the Dragon” Activations February 9<sup>th</sup> – March 2<sup>nd</sup>, 2024

## PROMOTION DESCRIPTION

BCLC and Light & Wonder will be hosting “Year of the Dragon” Activations at Participating Facilities to engage with players about the new Lunar New Year themed game, Dragons Jin Long Jin Bao and Dragon Spin Cross Link Water (the “**Promotion**”). At these “Year of the Dragon” Activations, players may engage with the Zodiac Spin Wheel to receive certain Free Play.

## DEFINITIONS

Capitalized terms used in this Promotion have the meaning assigned thereto in the Encore Rewards Terms and Conditions unless defined herein.

**Activation** means an event at a Participating Facility including an Activation Site and Activation Staff during the Activation Period.

**Activation Night** means a night during the Activation Period in which a Year of the Dragon Activation is occurring, as per the Schedule in Appendix A.

**Activation Period** means 6:00 pm – 12:00 am **PST** on select nights from **February 9<sup>th</sup>, 2024 – March 2<sup>nd</sup>, 2024**. Please see **Appendix A** for tentative Activation Schedule. *Activation Schedule is subject to change.*

**Activation Site** means the location within a Participating Facility where Qualified Players may visit to participate in this Promotion and includes the location of the Encore Rewards Game.

**Activation Staff** means Behaviour Inc. employees who attend the Activation Site during the Activation Period.

**Encore Rewards** means the points rewarded to individual members of the Program by BCLC.

**Encore Rewards Program** or **Program** means the membership and tiered bonus rewards program established by BCLC for players residing in British Columbia.

**Free Play** means a credit awarded as Encore Rewards for redemption on qualified slots or electronic table games.

**Qualified Player** is someone who is 19 years of age or older and has a valid Encore Rewards card or is eligible to become an Encore Rewards Member, but does not include:

- a British Columbia Lottery Corporation (“**BCLC**”) employee or contractor;
- a family or household member of any of the above who reside at the same address;
- a BCLC barred patron; or
- persons who are self-excluded, suspended or barred from a BC Casino or Community Gaming Centre.

**Participating Facility** means the locations where Activation Sites will be held. The participating facilities for this Promotion include:

**Zodiac Spin Wheel** means the game at the Activation Site in which players must engage to receive a prize.

**HOW TO PARTICIPATE IN THIS PROMOTION**

1. The Qualified Player visits an Activation Site during the Activation Period.
2. Prior to engaging with the Zodiac Spin Wheel, the Qualified Player must present Activation Staff with their Encore Rewards membership I.D. If the Qualified Player is not an Encore Rewards Member, they must sign up to the program prior to participating.
3. The Qualified Player spins the Zodiac Spin Wheel. The spin wheel is made up of two wheels: the outer wheel and the inner wheel.
  - a. A player starts by spinning the outer wheel.
    - If the outer wheel lands on the dragon zodiac sign, the Qualified Player will spin the inner wheel for a chance to win the **“Medium Tier Prize”** or the **“Top Tier Prize”**. A player wins the Top Tier Prize if the inner wheel lands on the dragon zodiac.
    - If the inner wheel lands on one of the other eleven (11) zodiac signs, the Qualified Player will win the Medium Tier Prize.
    - If the outer wheel does not land on the dragon zodiac, the Qualified Player wins the **“Lower Tier Prize”**.
4. Each Qualified Player gets one (1) chance to engage with the Zodiac Spin Wheel per Activation Night.
5. Each Qualified Player will receive the corresponding Prize the Zodiac Spin Wheel lands on.

**PRIZES**

6. There are three Prizes (each a **“Prize”**) Qualified Players have the chance to win:
  - a. Lower Tier Prize: \$5 Free Play
  - b. Medium Tier Prize: \$67 Free Play
  - c. Top Tier Prize: \$167 Free Play
7. The odds of winning a Prize depends on the position of the Zodiac Spin Wheel.
8. Each Qualified Player may only enter this Promotion once and receive a maximum of one (1) Prize per Activation Night.

9. Activation Staff will award Qualified Player’s Free Play as a voucher that can be used as follows:
  - a. Upon receiving the Free Play voucher from the Activation Staff, the Qualified Player must visit Guest Services at the Activation Site on the Activation Night to be awarded the Free Play which will be loaded onto their Encore Rewards card.
  - b. The Free Play voucher must be redeemed at the Participating Facility where it was awarded.
  - c. Once loaded on to their Encore Card, Qualified Players must use the Free Play at any Participating Facility within 365 days from the date it is awarded. To redeem the Free Play, Qualified Players must follow the Redeeming Points process found within the Encore Rewards Terms & Conditions.
  - d. The Free Play may only be redeemed on qualified slots or eTable games in gaming facilities or on Playnow.com.

**GENERAL CONDITIONS**

10. BCLC is not liable for lost, stolen, damaged, unregistered or improperly inserted Encore Rewards Cards, or any error or miscalculation.
11. Encore Rewards Cards must not be transferred. If an Encore Rewards member distributes their Encore Rewards Card to other players, they will not be eligible to participate in this Promotion and may have their Encore Rewards membership revoked.
12. BCLC reserves the right to not award any Encore Rewards in the event that the integrity of all, or a part, of the Promotion is compromised. Such a compromise shall include, but is not limited to, computer error, slot machine malfunction, electronic table malfunction, fraud, deception, misrepresentation or misuse.
13. BCLC may, at its sole discretion, and without liability to any individual, participant or Qualified Player, alter, amend, suspend, or cancel this Promotion at any time.
14. BCLC reserves the right to change or restrict Encore Rewards earnings or other awards on specific slot machines, or eTable games.
15. BCLC shall not be liable to any person for loss or damage to person or property resulting from or connected with acts or omissions of BCLC or any Participating Facility.
16. Each Qualified Player is responsible for ensuring that their Encore Rewards member profile is accurate and up-to-date and has current and correct contact information, including a telephone number and email address at which he or she can be contacted.

17. Qualified Players shall indemnify and save BCLC harmless from and against any and all actions, claims or demands brought by the Qualified Player (including costs incurred by BCLC in defending such actions, claims or demands) against BCLC which arise out of or are in any way connected to this Promotion.
18. Encore Rewards earned in this Promotion must be accepted as awarded, cannot be transferred, have no cash value and must be redeemed in accordance with the Offer Redemption Process and Encore Rewards Terms & Conditions.
19. You must notify BCLC of any omissions or discrepancies to your Encore Rewards balance within sixty (60) days of earning, receiving or using the applicable Points. BCLC may require you to provide documentation in support of any requested correction.
20. BCLC will not be liable for and may adjust or cancel your Encore Rewards balance where Encore Rewards have accrued due to malfunction, operator error, misrepresentation, fraud, misuse or any other reason BCLC deems valid.
21. In the instance of system error of Encore Rewards transactions, adjustments will not be made to player accounts where the difference (in favour of or against the player) is less than one (1) dollar within a single Gaming Day.
22. All BCLC decisions are final and binding. BCLC reserves the right to disqualify any individual or Qualified Player that does not comply with these terms and conditions.

  - (e) to administer responsible gaming programs, if you enroll in such program;
  - (f) for research, survey and statistical purposes;
  - (g) to customize the content and delivery of products, services and marketing;
  - (h) to expedite enrolment in other products and services provided by BCLC and BC Casinos or Community Gaming Centres that may be of interest to you;
