PLAY

Definitions

- 1. **BCLC** means British Columbia Lottery Corporation.
- 2. **MBLL** means Manitoba Liquor and Lotteries Corporation.
- 3. SIGA means Saskatchewan Indian Gaming Authority.
- 4. SaskGaming means Saskatchewan Gaming Corporation.
- 5. Drawn Entrant means an individual whose name is drawn to win a Prize as a result of the Prize Draw.

Qualified Entrant

- 9. A qualified entrant ("Qualified Entrant") means:
