

## **Definitions**

**BCLC** means British Columbia Lottery Corporation.

MBLL means Manitoba Liquor and Lotteries Corporation.

SaskGaming means Saskatchewan Gaming Corporation.

**SIGA** means Saskatchewan Indian Gaming Authority.

Casino Free Play means a token that may be used to wager on Eligible Games.

## Eligible Games means:

PlayNow.com casino games, excluding Live Casino, subject to availability.

**Held Funds** means the account where a player's winnings from a Token with a wagering requirement in progress are held.

## Eligible Participant(s) means:

- a British Columbia resident, nineteen (19) years of age or older with an active PlayNow.com account, who is not a:
  - BCLC employee; or
