
Definitions

BCLC means British Columbia Lottery Corporation.

MBLL means Manitoba Liquor and Lotteries Corporation.

SIGA means Saskatchewan Indian Gaming Authority.

Eligible Games means the PlayNow.com casino slot games listed on www.playnow.com/casino/promotions/lunar-new-year landing page.

Reseed Value means the dollar amount to which the Mystery Jackpots Widget automatically resets after a Promotional Jackpot is awarded. For this Promotion, the Reseed Value is **\$888 CAD**.

Eligible Participant(s) means:

For British Columbia:

- a British Columbia resident, nineteen (19) years of age or older with an active PlayNow.com account,

For Manitoba:

- a Manitoba resident, eighteen (18) years of age or older with an active PlayNow.com account,

For Saskatchewan:
