

2025 Lunar New Year Free Play Conditions

Definitions

BCLC means British Columbia Lottery Corporation.

MBLL means Manitoba Liquor and Lotteries Corporation.

SaskGaming means Saskatchewan Gaming Corporation.

SIGA means Saskatchewan Indian Gaming Authority.

Casino Free Play means a \$20 casino free play that may be used to wager on Eligible Games.

Eligible Games means:

- PlayNow.com slot casino games, excluding Live Casino, Table Games, Baccarat, and Roulette subject to availability.

Held Funds means the account where a player's winnings from a Casino Free Play with a wagering requirement in progress are held.

Eligible Participant(s) means:

- a British Columbia resident, nineteen (19) years of age or older with an active PlayNow.com account,
- a Manitoba resident, eighteen (18) years of age or older with an active PlayNow.com account
- a Saskatchewan resident, nineteen (19) years of age or older with an active PlayNow.com account

Promotion Period means:

For British Columbia:

- The Promotion Period is from 00:00:00 am PT on Monday, January 13, 2025 to 11:59:59 pm PT on Sunday, February 9, 2025.

For Manitoba and Saskatchewan:

- The Promotion Period is from 02:00:00 am CST on Monday January 13, 2025 to 01:59:59 am CST on Monday, February 10, 2025.

Wagering Requirement means the minimum dollar value on Eligible Games a player must spend before they are eligible to withdraw their winnings generated from Casino Free Play.

How to Receive Lunar New Year Casino Free Play

1. To receive a Casino Free Play under this Promotion, you must complete the following steps, in the following order:
 - a. Register for an account on PlayNow.com or log into your PlayNow.com account.
 - b. Enter the code **PROSPERITY** (the "**Promotion Code**") during the Promotion Period, in the "My Promotions" section of PlayNow.com.
 - c. Spend a minimum of \$10 (cumulative) on any PlayNow Casino slot games, excluding Live Casino, Table Games, Baccarat, and Roulette (the "**Spend Requirement**").
 - d. Casino Free Play will be automatically awarded to your account.

- e. A Promotion Code entered for a period before or after the Promotion Period will not be eligible for a Casino Free Play.
- 2. The Promotion Code may only be redeemed once.
- 3. Once credited to your account, the Casino Free Play must be used within 7 days. Casino Free Play will not be reissued following expiration.
- 4. In British Columbia and Manitoba, the Casino Free Play awarded from this Promotion have a 30x Wagering Requirement applied to it. In Saskatchewan, the Casino Free Play awarded from this Promotion has a 10x Wagering Requirement applied to it.

British Columbia and Manitoba Wagering Requirement Rules

- a. The Wagering Requirement for each Casino Free Play is thirty (30) times the value of redeemed Casino Free Play. You will meet the Wagering Requirement when the total dollar value of wagers made with the Casino Free Play add up to thirty (30) times the value of the Casino Free Play .
 - i. For example, for a \$20 Casino Free Play, the Wagering Requirement = $\$20 \times 30 = \600 (\$20 Casino Free Play+ \$580 play through of winnings). The Wagering Requirement is met when a player wagers the \$20 Casino Free Play and \$580 of winnings from that original Casino Free Play on eligible games.
- b. Until the Wagering Requirement is met, any winnings generated from the Casino Free Play will be deposited in your Held Funds account. You can play eligible games with Held Funds, but you cannot withdraw Held Funds from your account.
- c. Once the Wagering Requirement is met, any Held Funds remaining will be automatically transferred to your Cash Balance and can be withdrawn from your account or used on any game on PlayNow.com

Saskatchewan Wagering Requirement Rules

- e. The Wagering Requirement for each Casino Free Play is ten (10) times the value of redeemed Casino Free Play. You will meet the Wagering Requirement when the total dollar value of wagers made with the Casino Free Play add up to ten (10) times the value of the Casino Free Play.
 - i. For example, for a \$20 Casino Free Play, the Wagering Requirement = $\$20 \times 10 = \200 (\$20 Casino Free Play+ \$180 play through of winnings). The Wagering Requirement is met when a player wagers the \$20 Casino Free Play and \$180 of winnings from that original Casino Free Play on eligible games.
 - f. Until the Wagering Requirement is met, any winnings generated from the Casino Free Play will be deposited in your Held Funds account. You can play eligible games with Held Funds, but you cannot withdraw Held Funds from your account.
 - g. Once the Wagering Requirement is met, any Held Funds remaining will be automatically transferred to your Cash Balance and can be withdrawn from your account or used on any game on PlayNow.com
