



**Definitions**

**BCLC** means British Columbia Lottery Corporation.

**MBLL** means Manitoba Liquor and Lotteries Corporation.

**SIGA** means Saskatchewan Indian Gaming Authority.

**Eligible Games** means the PlayNow.com casino slot games listed on [www.playnow.com/casino/promotions/mega-vault](http://www.playnow.com/casino/promotions/mega-vault) landing page.

**Eligible Participant(s)** means:

For British Columbia:

- a British Columbia resident, nineteen (19) years of age or older with an active PlayNow.com account,

For Manitoba:

- a Manitoba resident, eighteen (18) years of age or older with an active PlayNow.com account,

For Saskatchewan:

### How to Participate
