



## Money Mania – Pyramid of Prizes Free Play Conditions

### Definitions

**BCLC** means British Columbia Lottery Corporation.

**MBLL** means Manitoba Liquor and Lotteries Corporation.

**SaskGaming** means Saskatchewan Gaming Corporation.

**SIGA** means Saskatchewan Indian Gaming Authority.

**Casino Free Play** means casino free play that may be used to wager on Eligible Games.

**Eligible Games** means:

- PlayNow.com casino games, excluding Live Casino, subject to availability.

**Eligible Participant(s)** means:

- a British Columbia resident, nineteen (19) years of age or older with an active PlayNow.com account, who is not a:
  - BCLC employee; or
  - Family or household member of a BCLC employee, or
- A Manitoba resident, eighteen (18) years of age or older with an active PlayNow.com account, who is not an:
  - MBLL employee; or
  - Immediate family member of an MBLL employee, defined as father, mother, brother, sister, spouse (including common-law), child or ward of the employee, or
- a Saskatchewan resident, nineteen (19) years of age or older with an active PlayNow.com account

**Held Funds** means the account where a player's winnings from a Casino Free Play with a wagering requirement in progress are held.

**Promotion Period** means:

For British Columbia:

- The Promotion Period is from 00:00:00 am PT on Monday, September 16, 2024, to 11:59:59 pm PT on Sunday, October 13, 2024.

For Manitoba

- The Promotion Period is from 02:00:00 am CDT on Monday September 16, 2024, to 01:59:59 am CDT on Monday, October 14, 2024.

For Saskatchewan:

- The Promotion Period is from 01:00:00 am CST on Monday September 16, 2024, to 01:59:59 am CST on Monday, October 14, 2024.

**Wagering Requirement** means the minimum dollar value on Eligible Games a player must spend before they are eligible to withdraw their winnings generated from Casino Free Play

There is a maximum of \$50 awarded in Casino Free Play during the Promotion Period.

2. Casino Free Play will be automatically awarded to your account.
  - a. A Promotion Code entered for a period before or after the applicable Validity Period will not be eligible for a Casino Free Play.
3. Each Promotion Code may only be redeemed once.
4. Once credited to your account, the Casino Free Play must be used within 7 days. Casino Free Plays will not be reissued following expiration.
5. Each Casino Free Play awarded from this Promotion has a 10x Wagering Requirement applied to them.

### Wagering Requirement Rules

  - b. Until the Wagering Requirement is met, any winnings generated from the Casino Free Play will be deposited in your Held Funds account. You can play eligible games with Held Funds, but you cannot withdraw Held Funds from your account.
  - c. Once the Wagering Requirement is met, any Held Funds remaining will be automatically transferred to your Cash Balance and can be withdrawn from your account or used on any game on PlayNow.com

6. An Eligible Participant may receive a maximum of one (1) Casino Free Play under this promotion during each Validity Period.
7. Casino Free Play awarded through this Promotion may only be used for wagering on Eligible Games.
