BCLC means British Columbia Lottery Corporation.

MBLL means Manitoba Liquor and Lotteries Corporation.

SIGA means Saskatchewan Indian Gaming Authority.

Eligible Games means the PlayNow.com casino slot games listed on www.playnow.com/summer-prize-drop landing page.

Eligible Participant(s) means:

For British Columbia:

- a British Columbia resident, nineteen (19) years of age or older with an active PlayNow.com account,

For Manitoba:

- a Manitoba resident, eighteen (18) years of age or older with an active PlayNow.com account,

For Saskatchewan:

Prize Drop Widget means the Prize Engine that needs to be launched to win a Promotional Jackpot.
