

Definitions

BCLC means British Columbia Lottery Corporation.

MBLL means Manitoba Liquor and Lotteries Corporation.

SaskGaming means Saskatchewan Gaming Corporation.

SIGA means Saskatchewan Indian Gaming Authority.

Casino Bonus means a casino bonus that may be used to wager on Eligible Games.

Eligible Games means any Live Casino game on PlayNow.com, excluding Baccarat and Roulette, subject to availability. Casino Bonuses earned through this promotion may be used on any Eligible Game.

Eligible Participant(s) means:

- a British Columbia resident, 19 years of age or older with an active PlayNow.com account
- a Saskatchewan resident, 19 years of age or older with an active PlayNow.com account,
- a Manitoba resident 18 years of age or older with an active PlayNow.com account
- provided that:

How to Participate
