

## **Definitions**

**BCLC** means British Columbia Lottery Corporation.

**MBLL** means Manitoba Liquor and Lotteries Corporation.

SaskGaming means Saskatchewan Gaming Corporation.

**SIGA** means Saskatchewan Indian Gaming Authority.

Casino Bonus means a casino bonus that may be used to wager on Eligible Games.

Eligible Games means PlayNow.com casino slot games, excluding live casino, subject to availability.

**Held Funds** means the account where a player's winnings from a Casino Bonus with a wagering requirement in progress are held.

## Eligible Participant(s) means:

- a British Columbia resident, 19 years of age or older with an active PlayNow.com account
- a Saskatchewan resident, 19 years of age or older with an active PlayNow.com account,
- a Manitoba resident 18 years of age or older with an active PlayNow.com account
- provided that:
  - individuals who are currently self-excluded or who self-exclude at any time during the Promotion Period from PlayNow.com are not Eligible Participants and are not eligible to receive a Token; and
  - individuals that are currently barred or are barred at any time during the Promotion Period from PlayNow.com, or a British Columbia, Manitoba, or Saskatchewan gaming facility, are not Eligible Participants and are not eligible to receive a Token.

Sports Bonus Bet means a sports bonus bet that may be used to wager on Playnow.com Sports.

Token means a Casino Bonus or a Sports Bonus Bet, or both.

**Wagering Requirement** means the minimum dollar value on Eligible Games a player must spend before they are eligible to withdraw their winnings generated from Casino Bonus.

## How to Receive a Summer Kickoff Surprise Token

1. To receive a Casino Bonus or Sports Bonus Bet under this Promotion, you must complete the following steps, in the following order:



- a. Register for an account on PlayNow.com or log into your PlayNow.com account.
- b. Enter the "**Promotion Code**" that corresponds during the applicable "**Validity Period**", as set out in the table below, in the "My Promotions" section of PlayNow.com.

There is a maximum of \$30 awarded in Casino Bonuses and \$5 in Sports Bonus Bets.

- c. A Promotion Code entered for a period before or after the Validity Period will not be eligible for a Token.
- 2. Each Promotion Code may only be redeemed once.
- 3. Once credited to your account, the Token must be used within seven (7) days. Tokens will not be reissued following expiration.
- 4. Each Casino Bonus awarded from this Promotion has a thirty (30) times Wagering Requirement applied to them.

## Wagering Requirement Rules

- a. The Wagering Requirement for each Casino Bonus is thirty (30) times the value of redeemed Casino Bonus. You will meet the Wagering Requirement when the total dollar value of wagers made with the Casino Free Play add up to thirty (30) times the value of the Casino Bonus
  - i. For example, for a \$10 Casino Bonus, the Wagering Requirement = \$10 x 30 = \$300 (\$10 Casino Bonus + \$290 play through of winnings). The Wagering Requirement is met when a player wagers the \$10 Casino Bonus and \$290 of winnings from that original Token on Eligible Games.
- b. Until the Wagering Requirement is met, any winnings generated from the Casino Bonus will be deposited in your Held Funds account. You can play Eligible Games with Held Funds, but you cannot withdraw Held Funds from your account.
- c. Once the Wagering Requirement is met, any Held Funds remaining will be automatically transferred to your cash balance and can be withdrawn from your account or used on any game on PlayNow.com

- 5. See the PlayNow.com Player Agreement for terms and conditions applicable to Tokens.



- 6. An Eligible Participant may receive a maximum of one (1) Casino Bonus or one (1) Sports Bonus Bet during each Validity Period.
- 7. Casino Free Play awarded through this Promotion may only be used for wagering on Eligible Games.
- 8. Wagers placed using a Token do not qualify for any other promotion on PlayNow.com.
