



## Casino Rebate Token Conditions

---

1. This promotion is available during the following promotional periods:

a. Weekend 1

(“**Promotion Period 1**”)

b. Weekend 2

Start Date/Time	End Date/Time
October 29, 2021 9:00:00 am PT/11:00:00am CT	October 31, 2021 11:59:59pm PT/November 1, 2021 1:59:59am CT

(“**Promotion Period 2**”)

(individually a “**Promotion Period**”, and collectively the “**Promotion Periods**”)

2. To receive your 10% Casino Rebate Token (“**Casino Rebate Token**”):

a. Log in to your PlayNow.com account and enter the promotion code **TREAT10** (the “**Promotion Code**”) on the My Promotions page.

b. Play any of the eligible PlayNow Casino games listed below (“**Eligible Casino Games**”) during either one or both of the Promotion Periods:

- i. Instants;
- ii. Slots;
- iii. Tables; and
- iv. Video Poker.

c. To receive a Casino Rebate Token, the value of your wager(s) on Eligible Casino Games during a Promotion Period must exceed the value of your winnings for that wager(s) (an “**Overall Loss**”) at the End Date/Time for that Promotion Period. See Appendix 1 for examples of the Overall Loss calculation.

- i. If you use a Token or funds from previous promotions for your wager(s) for this promotion, losses on those wagers will not count towards the calculation of Overall Loss.
- ii. If at the End Date/Time of a Promotion Period, your winnings exceed or are equal to your wager(s) on Eligible Casino Games for that Promotion Period, you are not eligible for the Casino Rebate Token.

- d. Your Casino Rebate Token will be 10% of the Overall Loss, subject to the value caps below.
3. A **Casino Rebate Token cannot be lower than \$5, or higher than \$1000.**
  - a. If you incur an Overall Loss during a Promotion Period, and 10% of the Overall Loss results in an amount lower than \$5, you are not eligible for a Casino Rebate Token.
  - b. If you incur an Overall Loss during a Promotion Period, and 10% of the Overall Loss results in an amount higher than \$1000, you are eligible for a Casino Rebate Token of \$1000 only.
4. The Casino Rebate Token will be credited to your PlayNow.com account in the form of a Token one to three business days following the End Date/Time of that Promotion Period.
5. Once credited to your account, the Casino Rebate Token must be used within 14 days after which it will expire. Casino Rebate Tokens will not be reissued following expiration.
6. Casino Rebate Tokens awarded for this promotion can only be used for wagering on PlayNow.com casino games (excluding Live Casino), subject to availability.

This player did not receive a token rebate because they **did not** incur an **overall loss** over the promotional period.

Game #2	-\$5.00	\$2.00	-\$3.00
Game #3	-\$15.00	\$3.00	-\$12.00
Game #4	-\$10.00	\$3.00	-\$7.00
Game #5	-\$20.00	\$5.00	-\$15.00
Overall Outcome			-\$51.00
Token Rebate (10% x overall loss)			-\$5.10
