



British Columbia Lottery Corporation (BCLC) Wolf Den Full Moon Fridays Activation November 18, 25, and December 2, 2022

PROMOTION DESCRIPTION

As part of the Wolf Den Promotion, BCLC & IGT will be hosting three (3) Activations at four (4) Participating Facilities on select Fridays during the Wolf Den Promotion called “**Full Moon Fridays**”. At these Full Moon Fridays, players may have their photo taken with a wolf sculpture and spin a “**Full Moon Wheel**” for a chance to win prizes. Players may also share their wolf sculpture photos on social media to receive a bonus spin and a \$5 PlayNow token (the “**\$5 Token**”).

DEFINITIONS

Capitalized terms used in this promotion have the meaning assigned thereto in the Encore Rewards Terms and Conditions unless defined herein.

Activation means an event at a Participating Facility including an Activation Site and Activation Staff during the Activation Period.

Activation Night means each Friday falling within the Activation Period.

Activation Period means 8:00 pm – 11:00 pm PST on:

- Friday November 18th 2022
- Friday November 25th 2022
- Friday December 2nd 2022

Activation Site means the location within a Participating Facility where Qualified Players may visit to participate in this Promotion, and includes a wolf statue, a photobooth, and a Full Moon Wheel.

Activation Staff means Inventa employees who attend the Activation Site during the Activation Period.

Branded Item means merchandise related to this Promotion and may include Wolf Den branded toques and water bottles.

Encore Rewards means the points rewarded to individual members of the Program by BCLC.

Encore Rewards Program or **Program** means the membership and tiered bonus rewards program established by BCLC for players residing in British Columbia.

Free Play means a credit awarded as Encore Rewards for redemption on qualified slots or electronic table games.

Participating Facility means the locations where Activation Sites will be held:

- Parq
- Grand Villa
- Cascades Delta
- River Rock

Qualified Player is someone who is 19 years of age or older and has a valid Encore Rewards card or is eligible to become an Encore Rewards Member, but does not include:

- BCLC, IGT, Inventa and Participating Facility employees as well as family and household members who reside at the same address; and/or
- Persons who are self-excluded, suspended or barred from a BC Casino or Community Gaming Centre.

1. The Qualified Player visits an Activation Site during the Activation Period.

2. The Qualified Player may have their photo taken with the wolf sculpture at the photobooth portion of the Activation Site. Qualified Players may enter their contact information to receive the photo via email or text.
3. The Qualified Player may spin the Full Moon Wheel for a chance to win a prize. Each player gets one (1) chance to spin the Full Moon Wheel per Activation Night. The breakdown of the prizes can be found in the **Prize** section of these Conditions, below.
 - a. **BONUS SPIN:** If the Player shows the Activation Staff that they have shared their wolf sculpture photo on social media and tag @CasinosBC on Facebook or Instagram, they will be entitled to one (1) bonus spin of the Full Moon Wheel.
 - b. Players who share their wolf sculpture photo on Facebook or Instagram with the tag @CasinosBC will also be awarded a \$5 Token.
 - 3.b.1. The \$5 Token will be sent directly to the Player's social media account and may take up to three (3) days to be awarded.
 - 3.b.2. To redeem the \$5 Token, Players must log into their PlayNow.com account and enter the code sent to them in the \$5 Token via their social media account.
 - 3.b.3. The \$5 Token must be redeemed on PlayNow.com within 14 days of entering the code.
 - 3.b.4. \$5 Tokens must be redeemed on PlayNow.com by March 31, 2023.
 - 3.b.5. Players may receive a maximum of one \$5 Token.
4. A Qualified Player wins a prize associated with the segment where the Full Moon Wheel stops. Prizes are not transferable, must be accepted as awarded, and may not be exchanged for cash.

probability of offers will be adjusted for the \$10 Free Play offer to 8/12 or 66.67% for Prize Table A, and 5/12 or 41.7% for Prize Table B.

6. If the Qualified Player wins **Free Play**, the Activation Staff will award them a voucher that can be used as follows:
 - a. The player must visit Guest Services at the Participating Facility to load their Free Play onto their Encore Rewards card for redemption.
 - b. Upon receiving the Free Play voucher from the Activation Staff, the Qualified Player has until December 3rd 2022 at 11:59:59 PM days to redeem the Free Play voucher. The Free Play offer must be redeemed at the Participating Facility where it was awarded. The Qualified Player must sign up for Encore Rewards if they are not already a member to have the Free Play loaded onto an Encore Rewards card. The Encore Rewards awarded can only be used for redemption on qualified slots or eTable games in gaming facilities or on Playnow.com.
 - c. Qualified Players must use the Free Play at any Participating Facility within 365 days from the date it is awarded. To redeem the Free Play, Qualified Players must follow the Redeeming Points process found within the Encore Rewards Terms & Conditions

11. BCLC reserves the right to not award any Encore Rewards in the event that the integrity of all, or a part, of the promotion is compromised. 24. BCLC will not be liable for and may adjust or cancel your Encore Rewards balance where Encore Rewards have accrued due to malfunction, operator error, misrepresentation, fraud, misuse or any other reason BCLC deems valid.
