

Qualified Entrant

- A qualified entrant (Entrant) in Manitoba is eighteen (18) years of age or older at the time of entry into the Contest during the Contest Period, with an open PlayNow.com account and is not
 - a British Columbia Lottery Corporation (BCLC) employee or contractor;
 - a Manitoba Liquor & Lotteries (MBLL) employee or contractor; or
 - Immediate family of an MBLL employee, defined as father, mother, brother, sister, spouse (including common-law), or child (including stepchild) of the employee.

Provided that:

- Individuals who are currently self-excluded or who self-exclude at any time during the Contest Period from PlayNow.com or a British Columbia or Manitoba gaming facility are not Qualified Entrants and are not eligible to win.
