



## 1. RULES AND REGULATIONS

The 7-Run Instant Ticket (the “Ticket”) is governed by these Game Conditions as well as the Rules and Regulations Respecting Lotteries and Gaming of the British Columbia Lottery Corporation (“**BCLC**”) and the Instant Ticket Game Conditions, which include limitations of liability and are available at [bclc.com](http://bclc.com), or upon request to BCLC.

## 2. SPONSORS

3. The prize sponsors (as set out below) are 7-Eleven Canada, Inc. (“7-Eleven”) and Ford Dealers Marketing Association of British Columbia (“Ford”) (each a “Sponsor” and collectively the “Sponsors”). Sponsorship is limited to the provision of prizes, as set out in these Game Conditions. This game is conducted and managed by BCLC.

## 4. GRAND PRIZE

The Grand Prize is a Ford 2025 Mustang Mach-E Premium. The Grand Prize is sponsored by Ford and provided by Metro Motors Ltd.

## 5. GRAND PRIZE DRAW ENTRY DEADLINE

To participate in the Grand Prize draw, Top Prize winners must claim their prize through BCLC’s prize claim process, available at [corporate.bclc.com](http://corporate.bclc.com) by **11:59pm PT on June 17, 2026**. Top Prize winners who do not claim their prize by this date and time forfeit their entry into the Grand Prize draw. Top Prizes may be claimed until the expiration date printed on the back of the ticket.

## 6. GRAND PRIZE DRAW

Top Prize winners who complete the claim and verification process in accordance with these Game Conditions will be entered into the Grand Prize draw. The Grand Prize draw will occur at a date and time determined by BCLC, once all Top Prize winners have completed the claim and verification process, or as soon as practicable thereafter. If all Top Prize winners have completed the prize claim and verification processes prior to June 17, 2026, BCLC may conduct the draw at an earlier date.

## 7. GRAND PRIZE CLAIM

A BCLC representative will contact the Grand Prize winner after the draw. The Grand Prize



winner must accept the Grand Prize within twenty-four (24) hours of first contact by the BCLC representative. If the Grand Prize winner does not accept the Grand Prize within this period, the Grand Prize is forfeit and another winner will be selected.

## **8. GRAND PRIZE RESTRICTIONS**

- a) The Ticket or its ownership cannot be transferred once all or any part of the play area has been scratched. Transfer of Ticket prior to the Grand Prize draw may result in disqualification from receiving a Top Prize, or entry into the Grand Prize draw.
- b) In order to receive the Grand Prize, the Grand Prize winner or their representative must provide any documentation, licenses, or information required by Metro Motors Ltd.
