

Definitions

MBLL means Manitoba Liquor and Lotteries Corporation.

Eligible Games means PlayNow.com lottery games, subject to availability, including: LOTTO MAX, LOTTO 649, WESTERN MAX, WESTERN 649, DAILY GRAND, EXTRA.

Eligible Participant(s) means:

- a Manitoba resident, eighteen (18) years of age or older;

Promo Code means the code that must be entered on the My Promotions page in order to participate in this offer.

Promotion means the Lottery Bonus offer available by entering a promo code on PlayNow.com.

Promotion Period means the period beginning on May 1, 2026 at 00:00 PDT / 02:00 CDT and ending on June 30, 2026 at 23:59 PDT / July 1, 2026 at 01:59 CDT, unless withdrawn earlier by BCLC, or MBLL in conjunction with BCLC, at their discretion.

Lottery Bonus means a prize awarded in the form of a PlayNow.com lottery bonus.

Qualifying Spend means the minimum amount (\$20) that must be wagered on Eligible Games during the Promotion Period to qualify for the Lottery Bonus. Only wagers funded from a player's cash balance count toward the Qualifying Spend; wagers funded by bonus funds, bonuss, vouchers, rebates, refunds, or other promotional instruments do not count.
