

**BCLC GROCERIES FOR A YEAR CONTEST
RULES & REGULATIONS**

NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT IMPROVE CHANCES OF WINNING. THE CONTEST IS VALID IN BRITISH COLUMBIA (AND IS OPEN ONLY TO ELIGIBLE PERSONS, AS SPECIFIED IN THE RULES BELOW). VOID ELSEWHERE AND WHEREVER PROHIBITED.

This Contest is administered by Pattison Food Group Ltd. ("**PFG**") and sponsored by British Columbia Lottery Corporation ("**BCLC**").

1. How to Enter

Each time you shop in a Participating Store during the Contest Period (as defined below), scan your More Rewards Card or accepted More Rewards barcode. You will then automatically be entered into the **BCLC GROCERIES FOR A YEAR** contest (the "**Contest**") when you purchase any of the products listed on Schedule "A" (the "**Products**") from any of PFG's stores operating as Save-On-Foods, Urban Fare, PriceSmart Foods, Quality Foods or Nesters Market (each a "**Participating Banner**") in the Province of British Columbia that sells the BCLC Products (each a "**Store**"). Each Product purchased equals one (1) entry into the Contest.

If you do not yet have a More Rewards Card, visit www.morerewards.ca/enroll to obtain your free More Rewards Card. If you are a More Rewards Member and do not wish to participate in this or any other PFG Contest, please see Customer Service in a Store and the appropriate arrangements will be made.

2. No Purchase Necessary

No purchase is necessary to enter the Contest. To enter without a purchase, fill in a manual entry form available at Customer Service in a Store and mail it to:

All manual entry forms must be received at the above address by 11:59 p.m. (Pacific Time), on **September 16, 2026**. Only one (1) manual entry form per envelope per day will be accepted. Mechanically reproduced entries will not be accepted. Manual entry forms will be subject to verification and will be declared null and void by PFG if the manual entry form is found to have been obtained outside legitimate channels of distribution as may be determined by PFG in its sole discretion.

PFG is not responsible for manual entry forms or automatic electronic entries which are lost, late, misdirected, damaged, incomplete, illegible, have insufficient postage, or are otherwise in any way not entered or eligible for the contest.

3. Contest Period

The Contest begins at Store opening on **August 13, 2026** and closes at 11:59 pm (Pacific Time) on **September 16, 2026** (the "**Contest Period**"). All purchases must be completed no later than the

close of the Contest Period. Any purchases made or entry forms received after the Contest Period will be declared invalid and will not be eligible for the Prize draw.

4. **Prize Drawing**

On or about **September 21, 2026** a random draw process from all entries received within the Contest Period will be conducted at the PFG head office in Langley, British Columbia. The PFG computer system will be used to make a random draw or random draws, as the case may be. The odds of winning the Grand Prize in this Contest are dependent upon the total number of eligible entry forms received during the Contest Period.

Secondary Draws will then be made from entry forms received for each Participating Banner, with three (3) draws per Participating Banner. The odds of winning a Secondary Prize are dependent upon the total number of entry forms received for each Participating Banner during the Contest Period.

5. **Prizes**

There is one (1) Grand Prize available to be won, consisting of "Groceries For a Year" which is a fixed total of \$5,200 in PFG gift cards equivalent to \$100 per week for a year, with no recurring payments or additional grocery benefits (the "**Grand Prize**"). The approximate retail value of the Grand Prize is five thousand two hundred dollars (\$5,200.00) CAD.

There will be eighteen (18) Secondary Prizes available to be won, each consisting of a \$100 PFG gift card. Secondary Prizes will be awarded by Participating Banner, with each of the six Participating Banners awarding three (3) Secondary Prizes. The approximate retail value of each Secondary Prize is one hundred dollars (\$100) CAD.

6. **Prize Not Transferable and No Substitutions**

Prize must be accepted as awarded. No cash equivalent or exchange of Prize is permitted. All aspects of the Prize are non-transferable until awarded. PFG reserves the right to make substitution for the Prize, which in the opinion of PFG, is of similar kind or value, without prior notice. Any and all expenses, costs and all local, provincial or federal taxes or sales taxes resulting from winning and accepting the Prize are the responsibility of the winner.

7. **Notification**

The entrant(s) whose names are drawn will be contacted by telephone using the telephone number noted on the manual entry form or on the current More Rewards records held by PFG. PFG will only contact selected entrant(s). Attempts will be made to contact each selected entrant during regular business hours for a period of three (3) business days after the date of the Prize draw. If a selected entrant cannot be contacted, fails to respond to any telephone messages left by PFG within this period, or the Prize is refused, then he/she/they will forfeit any right to the Prize and PFG may, in its sole discretion, select an alternate winner or withdraw the Prize. The winner must claim his/her/their Prize from the Store of his/her/their purchase, during normal store hours and personally.

It is the entrant's responsibility to keep his/her/their phone number current with PFG. If you would like to update your mailing address or phone number, log into your More Rewards online account and update the Account Settings section or complete a More Rewards Change of Address form available from a cashier or at our Customer Service.

8. Distribution of Prize

Selected entrant must claim their Prize as directed by PFG by no later than ten (10) business days after the date of the Prize draw. If the selected entrant has not claimed the Prize within this period, then he/she/they will forfeit any right to the Prize and PFG may, in its sole discretion, select an alternate winner or withdraw the Prize.

9. Eligibility

The contest is only open to residents of British Columbia who are 19 years of age or older at the time of entry. To be eligible to win a Prize in this Contest, you must be a More Rewards cardholder.

10. Entry Forms Property of PFG

All entry forms are the property of PFG and will not be returned for any reason whatsoever.

11. Contest Rules & Regulations

By participating in the Contest, the entrant(s) unconditionally agree to be bound by the Contest Rules & Regulations. The entrant(s) further agree to be bound by the decisions of PFG regarding the Contest Rules & Regulations or in any way relating to this Contest, as may be determined by PFG in its sole discretion, which will be final and binding in all respects.

12. Privacy / Use of Personal Information

All personal information of the entrant(s) collected through the Contest ("**Personal Information**"), such as their name, address, telephone number, e-mail address and age is collected for the purposes of administering and promoting this Contest and PFG. Each entrant, by entering the Contest, consents to and grants PFG the right to collect, use and disclose their Personal Information for the purpose of administering and promoting the Contest and PFG.

13. Skill-Testing Question

Before being declared a Prize winner, the selected entrant must successfully answer without assistance or mechanical aid, a time-limited mathematical skill-testing question as a condition to receiving the Prize.

14. Disqualification

PFG reserves the right, in its sole discretion, to disqualify any selected entrant who:

- (a) cannot be reached by PFG by telephone or has not responded to telephone messages left within three (3) business days of the Prize draw;

- (b) is unwilling or unable to comply with the Contest Rules & Regulations;
- (c) has not correctly answered the skill-testing questions within the allotted time;
- (d) has not claimed the Prize as directed by PFG within ten (10) business days of the Prize draw;
- (e) has tampered or attempted to tamper with the entry process or the operation of the Contest;
- (f) has not signed the Declaration, Release and Waiver Form in the form required by PFG within ten (10) business days of the Prize draw;
- (g) for any reason whatsoever is unable or does not wish to accept the Prize as awarded;
- (h) is not the age of majority in the province in which the Prize is claimed;
- (i) is not eligible by law; or
- (j) is deemed by PFG, in its sole discretion, to be ineligible, disqualified, or in non-compliance for any reason whatsoever.

In all such cases, the selected entrant will forfeit his/her/their right to the Prize without compensation and PFG may, in its sole discretion, select an alternate Prize winner or withdraw the Prize.

15. No Warranty

Neither PFG and BCLC nor their affiliates, subsidiaries, partners, sponsors, suppliers or otherwise make any warranty, representation or guarantee, express or implied, in relation to the Prize, including without limitation quality, merchantability or fitness for a particular purpose.

16. Release

By entering into this Contest, all entrant(s) (including the Prize winners) hereby agree to release, discharge and hold harmless PFG and BCLC and their affiliates, subsidiaries, sponsors, suppliers and advertising, promotion and service agencies involved in this Contest, including all of their respective directors, officers, employees or agents, from any and all loss, harm, liability, claims, damages, causes of action, costs or expense of any kind whatsoever with respect to or arising out of:

- (a) the entrant's participation in the Contest;
- (b) the entrant's participation in any Contest-related activity;
- (c) the entrant's acceptance, use, misuse or any other matter in relation to the Prize;
- (d) the distribution of the Prize; or
- (e) the administration of the Contest.

17. Limitations of Liability

PFG and BCLC are not responsible for and will assume no liability for:

- (a) entry forms which are lost, late, delayed, incomplete, postage due, illegible, damaged, destroyed, irregular, mutilated, forged, garbled, incorrectly addressed, misdirected, mechanically reproduced or are otherwise in any way not entered or eligible for the Contest;
- (b) incorrect or inaccurate information in the entry forms or in relation to the administration of the Contest whether caused by any of the equipment or programming associated with or utilized in the Contest or by any technical or human error which may occur, including without limitation typographical errors;
- (c) telephone, technical, network, online, electronic or computer failures of any kind regardless of the cause in relation to the administration of the Contest;
- (d) the failure of PFG to notify any selected entrant that their name has been drawn for any reason whatsoever;
- (e) the failure of PFG to receive a selected entrant's response for any reason whatsoever;
- (f) theft or destruction or unauthorized access to, or alteration of, entry forms;
- (g) any error in compiling entry forms;
- (h) any error in awarding the Prize;
- (i) any condition caused by events beyond the control of PFG and BCLC which disrupts or interferes with the Contest; or
- (j) any other similar events or circumstances whatsoever.

18. Declaration, Release and Waiver Form
