

British Columbia Lottery Corporation (BCLC)

How to Enter:

1. **One (1) entry** will be earned per Eligible Purchase during the Promotional Period. Purchaser must be of legal age to purchase lottery. Players may receive a maximum of one (1) entry per Eligible Purchase. There is no limit to the number of entries an individual may submit.

Players fill out their ballot(s) with their first name, last name, and phone number. Then enter them into the ballot box located in-store at the participating retailer. Only ballots entered within the promotional period will be accepted and participating in the Draw.

2. **No Purchase Necessary method of entry:**
