
MORE649 Lottery Bonus Offer (the “Promotion”)

DEFINITIONS

- “**BCLC**” means British Columbia Lottery Corporation.
- “**MBLL**” means Manitoba Liquor and Lotteries Corporation.
- “**Promotional Period**” means Wednesday, May 20 at 00:00:00 am PT / 02:00:00 am CT to Wednesday, July 29 at 23:59:59 pm PT / Thursday, July 30 at 01:59:59 am CT.

Qualified Participant means:

- A British Columbia resident, nineteen (19) years of age or older, who is a PlayNow.com account holder during the Promotion Period and who is not:
 - a participant in BCLC’s Game Break Program; or
 - an individual who is prohibited on PlayNow.com or a British Columbia gaming facility.
