
\$150 Live Casino Sign Up Bonus Conditions

1. To participate in this promotion, you must be:
 - a British Columbia resident 19 years of age or older, a Saskatchewan resident 19 years of age or older, or a Manitoba resident 18 years of age or older;
 - have an active PlayNow account; and
 - receive the promotional offer for this promotion.
2. To receive your \$150 Live Casino Sign Up Bonus Token you must complete these steps in order.
 - Register on PlayNow.com.
 - Select the \$150 Live Casino Offer during registration
 - Make a minimum initial deposit of \$5, up to \$150. An initial deposit is the first deposit made after registering for PlayNow.com.
 - Spend through your cumulative first deposit on any Live Casino games.
3. This promotion is only available for new PlayNow.com account holders.
4. Tokens cannot be used to meet the deposit or spend requirements outlined above.
5. Once credited to your account, the Token must be used within 14 days. Tokens will not be reissued following expiration.

Wagering Requirement Rules

- The wagering requirement is met when a player wagers the \$10 Token and \$490 of winnings from that original Token on eligible games.
- Until the wagering requirement is met, any winnings generated from the Token will be deposited in your Held Funds account. You can play eligible games with Held Funds but you cannot withdraw Held Funds from your account.
