

Definitions

BCLC means British Columbia Lottery Corporation.

MBLL means Manitoba Liquor and Lotteries Corporation.

SaskGaming means Saskatchewan Gaming Corporation.

SIGA means Saskatchewan Indian Gaming Authority.

Eligible Participant(s) means:

- a) <u>a British Columbia resident, nineteen (19) years of age or older with an open</u> <u>PlayNow.com account, who is not a</u>
 - <u>BCLC employee; or</u>
 - Family or household member of a BCLC employee, or
- b) <u>a Manitoba resident, eighteen (18) years of age or older with an active PlayNow.com</u> <u>account, who is not an:</u>

Sports Match Deposit Token Conditions

- 3. To receive your match deposit token ("**Sports Free Bet**") you must complete these steps in order:
 - a. Log into or register your PlayNow.com account in your jurisdiction.

- c. Make an initial single minimum deposit of \$10 into your account (the "Deposit Requirement"). Your Sports Free Bet amount is equal to the first deposit made after entering the Promotion Code, for an amount up to a maximum of \$250. If your deposit amount is over \$250, you will only receive the maximum \$250 in Sports Free Bet.
