

\$150 Live Casino Sign Up Bonus Conditions

1. To participate in this promotion, you must:
 - be a British Columbia resident 19 years of age or older, a Saskatchewan resident 19 years of age or older, or a Manitoba resident 18 years of age or older;
 - have an active PlayNow account; and
 - receive the promotional offer for this promotion.
2. The **Promotional Period (“Promotional Period”)** is outlined below:
 - British Columbia (BC)
 - The promotion period is from **April 1, 2026, at 12:00:00 AM PT to March 31, 2027 at 11:59:59 PM PT**
 - Saskatchewan (SK)
 - The promotion period is from **April 1, 2026, at 01:00:00 AM CST to April 1, 2027 at 12:59:59 AM CST**
 - Manitoba (MB)
 - The promotion period is from **April 1, 2026, at 02:00:00 AM CDT to April 1, 2027 at 1:59:59 AM CDT**
