

PROLINE Bet the Spread Contest Conditions
(the “Contest”)

January 26 - March 9, 2025

DEFINITIONS

Activation Site means the locations where Proline’s Bet the Spread Activations take place, as per the Schedule in Appendix A, where Qualified Players may visit to participate in the Contest.

Activation Day means a day during the Activation Period in which a Proline’s Bet the Spread activation is occurring, as per the Schedule in Appendix A.

BCLC means British Columbia Lottery Corporation.

Draw Period means the time at the end of each Activation Day in which the Winners will be randomly drawn from the pool of daily entrants. Estimated Draw Periods for each Activation Day are listed in the Schedule in Appendix A.

Prize means a \$250 credit discounted from a food and non-alcoholic drinks bill on the Activation Day at an Activation Site or a Secondary Prize.

Qualified Entrant means an individual 19 years of age or older, who is geographically located within British Columbia, and who is also not:

- a BCLC employee or contractor; or an employee of either Behaviour Inc. or Tradable Bits;
- a family and household member of any of the above who reside at the same address; and
- a BCLC barred patron or self-excluded from a BC Casino or BC Community Gaming Centre.

Qualified Entry means a single qualifying entry by placing a wager at the PROLINE self-serve terminal on an Activation Day and presenting the bet slip to Activation Staff to enter at the Activation Site.

Reserve Winner means the individual is drawn as a backup, and becomes a Winner in the event that the original Winner becomes disqualified.

Secondary Prize means items like memorabilia or a jersey, ranging from \$25-\$250.

Winner means the Qualified Entrant or Reserve Entrant who is awarded a Prize.

ACTIVATION PERIOD

1. The entry period for this Contest runs from 12:00:00 PT on January 26, 2025, to 23:59:00 PT on March 9, 2025 (“**Activation Period**”). Players must enter this Contest during the Activation Period at an Activation Site, subject to the Schedule in Appendix A. This Contest will be subject to these terms and conditions (“**Contest Conditions**”).

HOW TO ENTER

2. To enter this Contest, a Qualified Entrant must:

- a. visit an Activation Site during the Activation Period;
- b. place up to three (3) PROLINE bets (any wager amount) using the PROLINE self-serve terminal. Bets must be made on an Activation Day prior to the Draw Period; and
- c. present a maximum of three (3) bet slips to Activation staff, follow the instructions on the website, accurately submit your contact information, and opt-in to the Contest.

Qualified Entrants may obtain a maximum of three (3) Qualified Entries at each Activation Site during the Activation Period. For clarity, a Qualified Entrant may enter the Contest at one (1) Activation Site for each Activation Day.

THE PRIZE

3. At each Activation Site, there are two (2) “Win Your Spread” Prizes available to be won.
4. A Qualified Player may be awarded up to two (2) Prizes per Activation Site, one (1) \$250 credit towards their food and non-alcoholic drinks bill on the Activation Day of an Activation Site and one (1) Secondary Prize.
5. There are a total of 52 Prizes available to be won in this Contest.

THE DRAW

6. The Winner will be randomly drawn from all the Qualified Entries received during the Activation Day (the “**Draw**”). Representatives from Behaviour Inc. will conduct the draws using the Tradable Bits Platform.
7. The odds of winning a Prize depend on the number of entries received.
8. The Draw will occur at the end of each Activation Day as outlined in the Schedule in Appendix A. Winners must be physically present at the Activation Site to claim their Prize. If they are not present, a Reserve Winner will be drawn.
9. To claim a Prize, the Winner must present government issued photo ID that matches the name entered in the Contest.
