

Contest Period

This contest ("**Contest**") runs from 4:09:00 am PT on January 1, 2022 to 4:08:59 am PT on February 1, 2022 ("**Contest Period**") and will be subject to these contest conditions ("**Contest Conditions**").

Qualified Entrant

A qualified entrant ("**Qualified Entrant**") is a resident of British Columbia, 19 years of age or older who is not:

- 1. a British Columbia Lottery Corporation ("**BCLC**") employee, or an employee of either Vancouver Canucks Limited Partnership or Vancouver Arena Limited Partnership together with other affiliates operating as Canucks Sports & Entertainment ("**CSE**"), or a family and household member of the same residing at the same address;
- 2. an individual who is self-excluded or who self-excludes during the Contest Period from PlayNow.com or from a BCLC gaming facility; or
- 3. an individual that is barred from PlayNow.com or a BCLC gaming facility.

How to Enter

There are two ways to enter this Contest, each as defined below;

- 1. by correctly placing a PlayNow Sports Bet; or
- 2. by correctly submitting a free No-Purchase Necessary entry.

Qualified Entry

 "PlayNow Sports Bet": Qualified Entrants may obtain one (1) Qualified Entry by logging in to their PlayNow.com account, correctly entering the promotion code CANUCKSFAN during the Contest Period in the "My Promotions" section of PlayNow.com, and making a minimum \$5 wager on any NHL game during the Contest Period, which, for clarity, includes a Parlay bet containing at least one (1) selection on any NHL game.

Qualified Entrants may obtain a maximum of one (1) Qualified Entry each day during the Contest Period from a PlayNow Sports Bet. If more than one (1) Qualified Entry is received on the same day from a PlayNow Sports Bet, only the first Qualified Entry will count towards this Contest.

2. "**No-Purchase Necessary**": Qualified Entrants may obtain one (1) Qualified Entry by mailing an entry to British Columbia Lottery Corporation, 2940 Virtual Way, Vancouver, B.C., V5M 0A6, Attention: Marketing. The envelope must contain the entry, which must be on a single sheet of paper. The entry must contain the following information, which must be legible: name, mailing address with postal code, phone number and email address.

Only one (1) No-Purchase Necessary entry may be submitted per person in this Contest. Any mailing containing more than one entry, including multiple mail-ins by the same person, will be discarded, including any otherwise valid entry. Mail-in entries must be received by the close of the Contest Period in order to be eligible for a Prize, including the Grand Prize.

The Prizes

- fourteen winners (each a "Prize Winner") will receive a prize ("Prize"); and
