



Contest Period

This contest (the "**Contest**") runs from 12:00:01 am PT on June 7th, 2025 to 11:59:59 pm PT on October 17th, 2025 (the "**Contest Period**") and will be subject to these contest conditions (the "**Contest Conditions**").

This Promotion is governed by these terms and conditions (the "**Conditions**") as well as <u>BCLC's</u> <u>General Terms and Conditions for Promotions</u> (the "**General Conditions**"). Where the Conditions and the General Conditions conflict, these Conditions will prevail.

Qualified Entrant

A qualified entrant ("**Qualified Entrant**") is a resident of British Columbia, 19 years of age or older who is not:

- 1. a British Columbia Lottery Corporation ("**BCLC**") employee, an employee of BC LIONS FOOTBALL LIMITED PARTNERSHIP ("**BC Lions LP**"), or a family and household member of a BCLC or BC Lions LP employee who is residing at the same address;
- 2. an individual who is self-excluded or who self-excludes during the Contest Period from PlayNow.com or from a BCLC gaming facility; or
- 3. an individual that is prohibited from PlayNow.com or a BCLC gaming facility.

How to Enter

There are (2) two ways to enter this Contest, each as defined below:

- 1. by correctly submitting a Promo Code Redemption; or
- 2. by correctly submitting a free No-Purchase Necessary entry.

Qualified Entries

- "Promo Code Redemption": Qualified Entrants must have an active PlayNow account to enter the Contest using this entry method. Qualified Entrants with an active PlayNow account may obtain one (1) Qualified Entry per day by successfully entering the promotion code LIONSFAN during the Contest Period in the "MY PROMOTIONS" section of PlayNow.com and making a minimum \$5 wager on any Sports event during the Contest Period, which, for clarity, includes a Parlay bet. Qualified Entrants will receive two (2) additional Qualified Entries if they place a wager on any CFL game during the Contest Period.
 - a. For example, if a Qualified Entrant places one (1) \$5 wager on a CFL game, they will receive a total of three (3) Qualified Entries.
- 2. "No-Purchase Necessary": Qualified Entrants may obtain one (1) Qualified Entry per week by mailing an entry to British Columbia Lottery Corporation, 2940 Virtual Way, Vancouver, B.C., V5M 0A6, Attention: Sports Sponsorship. The envelope must contain the entry, which must be on a single sheet of paper. The entry must contain the following information, which must be legible: full name, mailing address with postal code, phone



number and email address. Only one (1) No-Purchase Necessary entry may be submitted per person per week in this Contest. A 'week' during the Contest Period will be from Saturday at 12:00:01 am PT to the following Friday at 11:59:59 pm PT. Any mailing containing more than one entry, including multiple mail-ins by the same person, or more than one entry received by BCLC during the same week will be discarded, including any otherwise valid entry. Mail-in entries must be received by the close of the Contest Period in order to be eligible for the Grand Prize.

The Draws

- For this contest, there will be two draws with two prizes.
 - Qualified Entries received during the Contest Period are entered into a random draw (the "Mid-season Draw") to select one (1) Qualified Entrant to win the mid-season prize (the "Mid-season Drawn Entrant"). This draw will include all ballots received from 12:00:01 am PT on June 7th, 2025 to 11:59:59 pm PT August 16th 2025.
 - The mid-season Draw will be performed on August 21st, 2025 or as soon as practicable thereafter and will be conducted by two (2) BCLC employees at the BCLC office in Vancouver.
 - Qualified Entries received during the Contest Period are entered into a random draw (the "Season End Draw") to select one (1) Qualified Entrant to win the midseason prize (the "Season End Drawn Entrant"). This draw will include all ballots received during the Contest Period. The Mid-season Drawn Entrant will be ineligible to win the Season End Draw.
 - The season end Draw will be performed on October 22nd, 2025 or as soon as practicable thereafter and will be conducted by two (2) BCLC employees at the BCLC office in Vancouver.
- If BCLC is unable to determine that a Drawn Entrant meets the requirements of this Contest, the Drawn Entrant will be disqualified, and another entry will be drawn. This process will continue until the Grand Prize is awarded, or until 12 pm PT (noon) on November 21st, 2025, whichever is earlier.
