

**1) Promotion:** Fan Cave Contest (the “**Promotion**”).

This Promotion is governed by these terms and conditions (the “**Conditions**”) as well as BCLC’s General Terms and Conditions for Promotions (the “**General Conditions**”). Where the Conditions and the General Conditions conflict, these Conditions will prevail.

**2) Promotion Period:** 12:00:00 am PT on Tuesday, September 2<sup>nd</sup>, 2025, to 11:59:59 pm PT on Monday, November 24, 2025 (“**Contest Period**”).

**3) Prize:** There are a total of six (6) prizes to be won. Each Prize is the same, a Fan Cave Experience which includes the following:

- a) Full and exclusive access to the Johnnie Walker Lounge at the Parq Casino in Vancouver, BC for the winner plus 10 friends from 1PM to 9PM on their Experience Prize date;
- b) One (1) night stay in the JW Marriott for you and 10 guests with a maximum of two (2) people per room.
- c) \$2,500 food & non-alcoholic beverage credit to the Johnnie Walker Lounge;
- d) PlayNow Sports Bonus Bets (\$100 per guest);
- e) Encore Rewards Casino Free Play at Parq Casino (\$100 per guest);
- f) PlayNow branded merchandise;
- g) NFL, NHL, or NBA merchandise for the Winner; and
- h) Custom and curated prizes and experiences based on the Winners’ preferences.

Each Prize has a total value of approximately \$7,000.

**4) Qualified Entrant:** In addition to the requirements for a Qualified Entrant in the General Conditions, for this Promotion, the Qualified Entrant must also:

- b) have an active PlayNow.com account with updated profile information;
- c) not be a family or household member of a BCLC employee or contractor; and

**5) How to Enter**

There are (2) two ways to enter this Contest (as outlined below):

- 1. by correctly submitting a Promo Code Redemption with an active PlayNow account; or
- 2. by correctly submitting a free No-Purchase Necessary entry through mail.

(each, a “**Qualified Entry**”)

**Qualified Entry Methods**

- 1. “**Promo Code Redemption**”: Qualified Entrants must have an active PlayNow account to enter the Contest using this entry method. Sports bonus bets cannot be used for this

promotion. Qualified Entrants with an active PlayNow account may obtain one (1) Qualified Entry per NFL Game in the 2025-2026 NFL season by completing the following steps;

- a. successfully entering the promotion code FANCAVE during the Promotion Period before the qualifying wagers are placed in the “MY PROMOTIONS” section of PlayNow.com;
- b. placing a Same Game Parlay wager;
  - i. of \$30 or greater;
  - ii. with minimum 3.00+ odds;
  - iii. on any NFL event; and
- c. the bet must settle.

Voided wagers and wagers that are cashed out shall not give rise to or result in the allocation of ballots to the participant.

2. **“No-Purchase Necessary”**: Qualified Entrants may obtain one (1) Qualified Entry per week by mailing an entry to British Columbia Lottery Corporation, 2940 Virtual Way, Vancouver, B.C., V5M 0A6, Attention: Sports Marketing. The envelope must contain the entry, which must be on a single sheet of paper. The entry must contain the following information, which must be legible: **full name, mailing address with postal code, phone number and email address**. Only one (1) No-Purchase Necessary entry may be submitted per person per week in this Contest. A “week” during the Contest Period will be from Tuesday at 12:00:01 am PT to the following Monday at 11:59:59 pm PT. - Qualified Entries received during the Contest Period are entered into six (6) random draws (the **“the Draws”**) to select one (1) Qualified Entrant to win the weekly Prize (the **“Drawn Entrant”**). This draw will include all ballots received within the dates outlined in the table below.
- The Draws will be performed as per the schedule above, or as soon as practicable thereafter and will be conducted by two (2) BCLC employees at the BCLC office in Vancouver.
