

- 1. To participate in this 2025 Ryder Cup \$5,000 Bonus Bet Pool promotion (the "**Promotion**") you must:
 - a. be a British Columbia or Saskatchewan resident 19 years of age or older, or a Manitoba resident 18 years of age or older, and
 - b. have an active PlayNow.com account.
- This Promotion starts on September 17, 2025 at 12:00:00 am PT / 1:00:00 am CST / 2:00:00 am CT and ends on September 26, 2025 at the start of the 2025 Ryder Cup at approximately 6:00:00 pm PT / 7:00:00 pm CST / 8:00:00 pm CT (the "Promotional Period").
- 3. To receive a Sports Bonus bet ("**Sports Bonus Bet**") under this Promotion, you must complete these steps in the following order:
 - a. Register for an account on PlayNow.com or log into your PlayNow.com account;
 - b. Make a 2025 Ryder Cup \$5,000 Bonus Bet Pool wager that:
 - i. is a minimum of \$10, and
 - ii. is on the Top Overall Points Scorer of the Ryder Cup. If the golfer you bet on is the Top Scorer of the 2025 Ryder Cup, you qualify for a share of the prize pool, and
- 4. A total prize pool of \$5,000 in Sports Bonus Bets will be split equally among all participants who bet on the golfer who wins the Top Scorer of the Ryder Cup, regardless of which team wins the Ryder Cup.
 - a. Example: A participant wagers on Golfer A to win the Ryder Cup, but Golfer A is on Team USA. If Golfer A is the Top Scorer in the tournament, but Team Europe wins the Ryder Cup, that participant earns an equal share of the five-thousand-dollar (\$5,000) Sports Bonus Bet prize pool. If 250 participants bet on Golfer A as the outright winner as Top Scorer, each would receive a twenty-dollar (\$20) Sports Bonus Bet (\$5,000 ÷ 250 = \$20).
- 5. This Promotion only applies to the first eligible wager placed, and subsequent wagers will not earn multiple shares in the \$5,000 Sports Bonus Bet pool split payout.
- 6. Participants who placed their qualifying wager on the golfer who wins Top Scorer of the tournament will receive their Sports Bonus Bet as one token.
- 7. In the event that multiple golfers tie as Top Scorer of the 2025 Ryder Cup, the entire \$5,000 Sports Bonus Bet prize pool will be split equally among all qualifying participants who wagered on any of the tied golfers.
 - a. Example: If Golfer A and Golfer B tie as Top Scorer, and 200 participants bet on Golfer A while 100 participants bet on Golfer B, each of the 500 qualifying

participants would receive a ten-dollar (\$10) Sports Bonus Bet ($$5,000 \div 500 = 10).

- 8. For the purposes of calculating each qualifying participant's share of the \$5,000 Sports Bonus Bet prize pool, the division shall be based on the number of unique eligible participants, not on the total number of wagers placed.
 - a. Example: A participant places three separate qualifying wagers on Golfer A to be Top Scorer. If Golfer A is the Top Scorer, that participant will receive only one share of the prize pool, the same as any other unique participant who correctly selected Golfer A, regardless of the number of wagers placed.
- 9. Wagers that would otherwise be eligible but settle as void do not qualify for this Promotion.
- 10. A Sports Bonus Bet will be awarded up to 72 hours after the bets have been settled.
- 11. Sports Bonus Bet awarded through this Promotion expires 14 days after being awarded. An expired Sports Bonus bet will not be reissued following expiration.
- 12. Wagers placed using a Sports Bonus Bet do not qualify for any other promotion on PlayNow.com.
- 13. A Sports Bonus Bet awarded through this Promotion can only be used for wagering on PlayNow.com sports bets.
- 14. In the event PlayNow determines a Player is misusing, exploiting, or manipulating any sportsbook promotion or bonus system, PlayNow reserves the right to revoke any Player's eligibility for current and future promotions.
- 15. A Sports Bonus Bet must be accepted as awarded and cannot be exchanged for cash.
- 16. British Columbia Lottery Corporation ("BCLC"), Saskatchewan Indian Gaming Authority ("SIGA") in conjunction with BCLC, and Manitoba Liquor and Lotteries Corporation ("MBLL") in conjunction with BCLC, reserve the right, in their discretion, to adjust or cancel any Bonus Bets for any reason including if awarded in error.
- 17. BCLC, SIGA in conjunction with BCLC, or MBLL in conjunction with BCLC reserve the right to disqualify entrants and/or entries that do not comply with these conditions, the Player Agreement, or other applicable Rules or Terms of Use (each as defined in the Player Agreement, collectively the "Lottery Rules"). In the event of a conflict between these conditions and any lottery scheme, the applicable Lottery Rules will prevail.
- 18. This Promotion, Sports Bonus Bets and the use of Bonus Bets are subject to applicable terms and conditions, including the PlayNow.com Player Agreement. See the PlayNow.com Player Agreement for terms and conditions applicable to Bonus Bets.
- 19. This Promotion may be withdrawn, extended, or amended by BCLC, SIGA in conjunction with BCLC, or MBLL in conjunction with BCLC at any time.
- 20. All stated dollar amounts are in Canadian funds.





- 21. If validation of your PlayNow.com account is pending, the Sports Bonus Bet will be deposited when your PlayNow.com account is validated providing all conditions have been met.
- 22. All decisions of BCLC, SIGA in conjunction with BCLC, or MBLL in conjunction with BCLC, are final and binding.
