

## **Definitions**

**"Contest"** means this Triple Header Contest. Except as otherwise specified in these Contest Conditions, this Contest is governed by these terms and conditions (the **"Conditions"**) as well as <u>BCLC's General Terms and Conditions for Promotions</u> (the **"General Conditions"**). Where the Conditions and the General Conditions conflict, these Conditions will prevail.

"Contest Day" means the twenty-four-hour period from 0:00:00 am PT/2:00:00 am CT to 23:59:59 pm PT/ 1:59:59 am CT during the Contest Period in which a player may obtain one (1) Qualified Entry.

#### "Contest Period" means:

- a. For British Columbia: 0:00:00 am PT on October 28, 2025, to 23:59:59 pm PT on February 21, 2026;
- b. For Saskatchewan: 1:00:00 am CST on October 28, 2025, to 1:59:59 am CST on February 22, 2026; and
- c. For Manitoba: 2:00:00 am CST on October 28, 2025, to 1:59:59 am CST on February 22, 2026, in Manitoba

"Drawn Entrant" means an individual whose name is drawn to win a Prize as a result of the Prize Draw.

"MBLL" means Manitoba Liquor and Lotteries Corporation.

"Prize Winner(s)" or "Grand Prize Winner(s)" means the Drawn Entrant or Reserve Drawn Entrant who fulfills these Contest Conditions.

"Reserve Drawn Entrant" means an individual whose name is drawn as a backup as a result of the Prize Draw and who becomes a Qualified Entrant in the event that the original Drawn Entrant becomes disqualified.

"SIGA" means Saskatchewan Indian Gaming Authority.

"SaskGaming" means Saskatchewan Gaming Corporation.

#### "Qualified Entrant" means an individual who:

- a) is a British Columbia resident, 19 years of age or older with an active PlayNow.com account, who is not a BCLC employee;
- b) is a Saskatchewan resident, 19 years of age or older with an active PlayNow.com account;
- c) is a Manitoba resident 18 years of age or older with an active PlayNow.com account, who is not a MBLL employee; and



- d) is not:
  - an individual who is currently self-excluded or who self-excludes at any time during the Contest Period from PlayNow.com; and
  - an individual that is currently barred or is barred at any time during the Contest Period from PlayNow.com, or a British Columbia, Manitoba, or Saskatchewan gaming facility, are not Qualified Entrants and are not eligible to win a Prize.

## **How to Enter**

There are (2) two ways to enter this Contest (as outlined below):

- 1. Obtain a "Qualified Entry" through PlayNow.com;
- 2. Submit a No Purchase Necessary Entry.

## Entry Option 1: Qualified Entry on PlayNow.com

- 1) "Promo Code Redemption" means:
  - a) Qualified Entrants must have an active PlayNow account to enter the Contest using this entry method. Sports bonus bets cannot be used for this promotion.
     Qualified Entrants with an active PlayNow account may obtain one (1) Qualified Entry per Contest Day by completing the following steps;
    - successfully entering the promotion code "TRIPLE" during the Promotion Period before the qualifying wagers are placed in the "MY PROMOTIONS" section of PlayNow.com;
    - ii. placing a parlay wager;
      - 1. of \$20 or greater;
      - 2. with minimum 2.50+ odds;
      - 3. with minimum 2-legs;
      - 4. on any two or more MLB, NHL, or NBA events; and
    - iii. the bet must settle.

In instances where one or more selections within a bet are voided, the remaining selections must still satisfy the minimum odds criteria in order for the wager to qualify for ballot eligibility. Cashed out wagers shall not give rise to or result in the allocation of ballots to the participant.

# **Entry Option 2: No Purchase Necessary Entry**

- 2) "No-Purchase Necessary Mail-In" means:
  - a) No purchase is necessary to enter this contest. To obtain a No Purchase Necessary Entry, a Qualified Entrant may obtain ten (10) Qualified Entries by mailing an entry to British Columbia Lottery Corporation, 2940 Virtual Way, Vancouver, B.C., V5M 0A6, Attention: Sports Marketing, Triple Header Sports Contest. The envelope must contain the entry, which must be on a single sheet



- of paper. The entry must contain the following information, which must be legible: full name, mailing address with postal code, phone number, and email address, and PlayNow ID;
- b) Each Qualified Entrant may submit a maximum of one (1) No Purchase Necessary Mail-In.
- c) All No Purchase Necessary Mail-Ins must be received by the end of the Contest Period.

## **The Prizes**
