

Two Game Tackle \$50 Sports Freebet & \$50 Casino Freeplay Conditions

- 1. To participate in this Two Game Tackle \$50 Sports Freebet & \$50 Casino Freeplay promotion (the "**Promotion**") you must:
 - a. be a Saskatchewan resident 19 years of age or older
 - b. have an active PlayNow.com account.
- 2. To receive your \$50 Sports Freebet and \$50 Casino Freeplay Token ("**Sports Freebets** and Casino Freeplays") during the Promo Period, you must complete the following steps in order:
 - Register for an account on PlayNow.com or log into your PlayNow.com account;
 and
 - b. Enter the applicable promotion code: **TACKLE** on the My Promotions page (the "**Promo Code**").
 - c. Make a single minimum deposit of \$10 into your account (the "**Deposit** Requirement").
 - d. Spend \$10 of the deposit amount on any PlayNow sports wager (the "**Spend Requirement**").
 - e. You may place multiple bets to meet the Spend Requirement. If you are placing multiple bets to meet the Spend Requirement, all such bets must be placed within the Promotional Period.
- 3. This Promotion starts on May 27th, 2023 at 12:05:59 am PT / 01:05:59 am CST / 02:05:59 am CDT and ends on November 19th, 2023 at 09:59:59 pm PT / 10:59:59 pm CST / 11:59:59 pm CDT (the "Promo Period").
- 4. Tokens from other promotions, freeplay or other credits cannot be used to meet the Deposit Requirement or Spend Requirement for this promotion.
- 5. This Promo Code and each Sports Freebet and Casino Freeplay may be redeemed only once.
- 6. Your Sports Freebets will be credited to your account in TWO increments of \$25.
- 7. The Sports Freebet awarded through this Promotion is subject to the following conditions:
 - The Sports Freebet can only be used for wagering on PlayNow.com sports bets;
 and
 - b. The entire value of each Sports Freebet must be used on a single bet or parlay bet within a single transaction on the bet slip. It is not possible to use a Sports



Freebet across multiple bets on your bet slip.

- 8. Sports Freebets awarded through this Promotion expire 60 days after being awarded. Expired Sports Freebets will not be reissued following expiration.
- 9. Wagers placed using a Sports Freebet do not qualify for any other promotion on PlayNow.com.
- 10. Sports Freebets awarded through this Promotion can only be used for wagering on PlayNow.com sports bets.
- 11. Sports Freebets must be accepted as awarded and cannot be exchanged for cash.
- 12. Wagering Requirement Rules
 - a. A wagering requirement is a condition applied to a Casino Freeplay and affects how a player is able to spend the winnings generated by that promotion.
 - b. A Casino Freeplay awarded has a 30x wagering requirement: i. Therefore, for a \$100 Freeplay, the wagering requirement = \$50 x 30 = \$1500 (\$50 Freeplay + \$1450 play through of winnings).
 - c. The wagering requirement is met when a player wagers the \$50 Freeplay and \$1450 of winnings from that original offer on eligible games.
 - d. Until the wagering requirement is met, any winnings generated from the Freeplay will be deposited in your Held Funds account. You can play eligible games with Held Funds but you cannot withdraw Held Funds from your account.
 - e. Held funds generated from the offer may only be used on Casino games (excluding Live Casino).
 - f. Once the wagering requirement is met, any Held Funds remaining will be transferred to your Cash Balance and can be withdrawn from your account or used on any game on PlayNow.com
