

Definitions

BCLC means British Columbia Lottery Corporation.

MBLL means Manitoba Liquor and Lotteries Corporation.

SaskGaming means Saskatchewan Gaming Corporation.

SIGA means Saskatchewan Indian Gaming Authority.

Eligible Participant(s) means:

- a British Columbia resident, who is nineteen (19) years of age or older with an active PlayNow account; or
- a Manitoba resident, who is eighteen (18) years of age or older with an active PlayNow account; or
- a Saskatchewan resident, who is nineteen (19) years of age or older with an active PlayNow account.

Sports Bonus Bet means a token awarded in the form of a PlayNow.com Sports Bonus Bet.

Promotion Period means the period of time the promo code will be available for this Promotion as outlined in the promo code offer.
