

Definitions

BCLC means British Columbia Lottery Corporation.

MBLL means Manitoba Liquor and Lotteries Corporation.

SaskGaming means Saskatchewan Gaming Corporation.

SIGA means Saskatchewan Indian Gaming Authority.

Eligible Participant(s) means:

- a British Columbia resident, nineteen (19) years of age or older;
- a Manitoba resident, eighteen (18) years of age or older; or
- a Saskatchewan resident, nineteen (19) years of age or older.

Sports Free Bet means a token awarded in the form of a PlayNow.com Sports free bet token.
