

Contest Period

- This contest (“**Contest**”) runs from 12:00:00 am PT on February 19, 2024 (“**Contest Start**”) to 07:00:00 pm PT on February 25, 2024 (“**Contest Period**”) and will be subject to these contest conditions (“**Contest Conditions**”). There are three (3) entry periods (each a “**Draw Entry Period**”) for this Contest:
 1. from Contest Start to 07:00:00 pm on February 23, 2024 (“**First Draw Entry Period**”);
 2. from Contest Start to 07:00:00pm PT on February 24, 2024 (“**Second Draw Entry Period**”); and
 3. from Contest Start to 07:00:00pm PT on February 25, 2024 (“**Third Draw Entry Period**”).

Qualified Entrant

- A qualified entrant (“**Qualified Entrant**”) is a resident of British Columbia, 19 years of age or older who is not:
 1. a British Columbia Lottery Corporation (“**BCLC**”) employee, or an employee of either Canada Men’s International Sevens Limited Partnership or Tradable Bits, or a family and household member of the same residing at the same address;
 2. an individual who is self-excluded or who self-excludes during the Contest Period from PlayNow.com or from a BCLC gaming facility; or
 3. an individual that is barred from PlayNow.com or a BCLC gaming facility.

How to Enter

- No purchase is necessary to enter this Contest.
- Qualified Entrants may obtain one (1) qualified entry (“**Qualified Entry**”) by successfully completing the following steps during the Contest Period:
 1. successfully submitting a completed entry form (“**Entry Form**”) through the PlayNow Pick-Em Kick-Em landing page: playnow.com/pickem. The Entry Form will require the Qualified Entrant to provide their name, contact information and other information.
 2. The Qualified Entrant must enter their prediction on the Entry Form as to which participant will win each of the \$7K 7S KICK-EM CHALLENGE, scheduled to take place during an intermission on February 23, 24 and 25 at the HSBC World Rugby 7s Series event in Vancouver.

Prizes

- There are three (3) prizes to be won in this Contest, one for each Draw (as defined below).
- A Qualified Entrant will only be eligible to win one (1) Prize.
- The winner of each Draw (each a “**Prize Winner**”) will receive a prize (“**Prize**”) comprised of \$1,000 and a \$100 PlayNow Free Play Voucher (total Prize value is approximately \$1,100) by mailed cheque.

The Draws

- All Qualified Entries received during the First Draw Entry Period will be entered into the first random draw on or about February 26, 2024 (the “**First Draw**”) to select one (1) Qualified Entry for a Prize (the “**First Drawn Entry**”).

- Qualified Entries received during the Third Draw Entry Period, with the exception of the First Drawn Entry, Second Drawn Entry and disqualified entries (if any), will be entered into the third random draw on or about February 26, 2024 (the “**Third Draw**”) to select one (1) Qualified Entry for a Prize (the “**Third Drawn Entry**”).
- The First Draw, the Second Draw and the Third Draw (each, a “**Draw**”) will be conducted by two (2) BCLC employees or its agent.
- If BCLC is unable to determine that the First Drawn Entry meets the requirements of this Contest, the First Drawn Entry will be disqualified and another entry will be drawn. This process will continue until the Prize is awarded for the First Draw. Any disqualified Drawn Entries will not be entered into the Second or Third Draw.
- If BCLC is unable to determine that the Second Drawn Entry meets the requirements of this Contest, the Second Drawn Entry will be disqualified and another entry will be drawn. This process will continue until the Prize is awarded for the Second Draw.
- If BCLC is unable to determine that the Third Drawn Entry meets the requirements of this Contest, the Third Drawn Entry will be disqualified and another entry will be drawn. This process will continue until the Prize is awarded for the Third Draw.
- Each Draw will be conducted by two (2) BCLC employees or its agent.
