

## Contest Period

This contest (“**Contest**”) runs from 12:00:00 am PT on February 27, 2023 (“**Contest Start**”) to 07:00:00 pm PT on March 5, 2023 (“**Contest Period**”) and will be subject to these contest conditions (“**Contest Conditions**”). There are two entry periods for this Contest:

1. from Contest Start to 06:00:00 pm on March 4, 2023 (“**First Draw Entry Period**”); and
2. from Contest Start to 07:00:00pm PT on March 5, 2023 (“**Second Draw Entry Period**”).

## Qualified Entrant and Entry

A qualified entrant (“**Qualified Entrant**”) is a resident of British Columbia, 19 years of age or older who is not:

1. a British Columbia Lottery Corporation (“**BCLC**”) employee, or an employee of either Canada Men’s International Sevens Limited Partnership or Tradable Bits, or a family and household member of the same residing at the same address;
2. an individual who is self-excluded or who self-excludes during the Contest Period from PlayNow.com or from a BCLC gaming facility; or
3. an individual that is barred from PlayNow.com or a BCLC gaming facility.

No purchase necessary.

Qualified Entrants may obtain one (1) qualified entry (“**Qualified Entry**”) by successfully completing the following steps during the Contest Period:

1. successfully submitting a completed entry form (“**Entry Form**”) submitting an entry through the PlayNow Pick-Em Kick-Em landing page: [playnow.com/pickem](https://playnow.com/pickem). The Entry Form will require entrants to provide the entrant’s name, contact information and other information, and also to enter their prediction as to which participant will win each of the \$7K 7S KICK-EM CHALLENGE, scheduled to take place during an intermission on March 4<sup>th</sup> and 5<sup>th</sup> at the HSBC World Rugby 7s Series event in Vancouver. If entering after the close of the First Draw Entry Period, entrants will be required to enter their prediction as to which participant will win the \$7K 7S KICK-EM CHALLENGE on March 5<sup>th</sup> only. The eligible participants in the \$7K 7S KICK-EM CHALLENGE will be listed on the entry form together with certain details about them;
2. through the link provided following submission of the Entry Form, either log in to the entrant’s PlayNow.com account or sign up to obtain a PlayNow.com account, and correctly enter the promotion code **RUGBY20** during the Contest Period in the “My Promotions” section of PlayNow.com.

## One Entry for Two Draws

Qualified Entrants may obtain a maximum of one (1) Qualified Entry during the entire Contest Period. Qualified Entries received during the First Draw Entry Period will be included in the First Draw (defined below) and, if such Qualified Entry is not drawn in the First Draw, it will be included in the Second Draw (defined below), subject to these Contest Conditions.

## The Prizes

- There are two (2) prizes to be won in this Contest, one for each Draw.
- The winner of each Draw (each a “**Prize Winner**”) will receive a prize (“**Prize**”) comprised of \$1,000 CAD and a \$100 PlayNow Free Play Voucher (total prize value approximately \$1,100).

## The Draws

- All Qualified Entries received during the First Draw Entry Period will be entered into the first random draw on or about March 6, 2023 (the “**First Draw**”) to select one (1) Qualified Entry for a Prize (the “**First Drawn Entry**”).

- Qualified Entries received during the Second Draw Entry Period, with the exception of the First Drawn Entry and disqualified entries (if any), will be entered into the second random draw on or about March 6, 2023 (the “**Second Draw**”) to select one (1) Qualified Entry for a Prize (the “**Second Drawn Entry**”).
- The First Draw and the Second Draw (each, a “**Draw**”) will be conducted by two (2) BCLC employees or its agent.
- If BCLC is unable to determine that the First Drawn Entry meets the requirements of this Contest, the First Drawn Entry will be disqualified and another entry will be drawn. This process will continue until the Prize is awarded for the First Draw. Any disqualified Drawn Entries will not be entered into the Second Draw.
- If BCLC is unable to determine that the Second Drawn Entry meets the requirements of this Contest, the Second Drawn Entry will be disqualified and another entry will be drawn. This process will continue until the Prize is awarded for the Second Draw.
- A BCLC representative will attempt to contact each entrant of the First Drawn Entry and the Second Drawn Entry (each, a “**Drawn Entrant**”) via a telephone call or email, or both, within five (5) business days after the First Draw and the Second Draw, as applicable.
- A maximum of three (3) attempts will be made to contact each Drawn Entrant via telephone call or email.
- Each Drawn Entrant will have three (3) business days from the initial contact attempt to accept the Prize. If BCLC is not successful in contacting the Drawn Entrant, another entry will be drawn from among the remaining Qualified Entries in the applicable Draw, and the new drawn entrant will be contacted for the respective prize.
- Each Prize Winner must provide one (1) piece of government-issued, photographic identification acceptable to BCLC, complete such representations and indemnities as required by BCLC, and correctly answer a skill-testing question in order to receive the Prize. BCLC reserves the right to disqualify any Qualified Entrant that does not complete each of these conditions.

Odds of winning a Prize in the Second Draw are dependent upon the number of Qualified Entries received during the Second Draw Entry Period (being the entire Contest Period) in accordance with these Contest Conditions.
- It is not a requirement to correctly predict the winner of either or both KICK-EM CHALLENGE competitions for a Qualified Entry to be included in a Draw. Correctly predicting the winner of a KICK-EM CHALLENGE does not increase a Qualified Entrant’s chances of winning a Prize.
- It is the responsibility of each Qualified Entrant to ensure that their PlayNow.com account has current, accurate information, including a current telephone number and email address at which they can be contacted.
