

## Contest Period

This contest (the “**Contest**”) runs from 12:00:01 am PT on June 23<sup>rd</sup>, 2023 to 11:59:59 pm PT on July 23<sup>rd</sup>, 2023 (the “**Contest Period**”) and will be subject to these contest conditions (the “**Contest Conditions**”).

## Qualified Entrant

A qualified entrant (“**Qualified Entrant**”) is a resident of British Columbia, 19 years of age or older who is not:

1. a British Columbia Lottery Corporation (“**BCLC**”) employee, an employee of Vancouver Whitecaps FC, or a family and household member of a BCLC or Vancouver Whitecaps FC employee who is residing at the same address;
2. an individual who is self-excluded or who self-excludes during the Contest Period from PlayNow.com or from a BCLC gaming facility; or
3. an individual that is prohibited from PlayNow.com or a BCLC gaming facility.

## How to Enter

There are three ways to enter this Contest, each as defined below:

1. by correctly submitting a Registration of a New PlayNow Account;
2. by correctly submitting a Promo Code Redemption; or
3. by correctly submitting a free No-Purchase Necessary entry.

## Qualified Entry

1. “**Registration of a New PlayNow Account**”: Qualified Entrants may obtain one (1) qualified entry to the Draw (as defined below) (“**Qualified Entry**”) by successfully registering a new PlayNow account and entering the promotion code **FANFLIGHT** during the Contest Period in the “MY PROMOTIONS” section of PlayNow.com and making a minimum \$5 wager on any Sports event during the Contest Period, which, for clarity, includes a Parlay bet.
2. “**Promo Code Redemption**”: Qualified Entrants with an existing PlayNow account may obtain one (1) Qualified Entry by successfully entering the promotion code **FANFLIGHT** during the Contest Period in the “MY PROMOTIONS” section of PlayNow.com and making a minimum \$5 wager on any Sports event during the Contest Period, which, for clarity, includes a Parlay bet.

Qualified Entrants may obtain a maximum of one (1) Qualified Entry during the Contest Period from a Registration of a New PlayNow Account or a Promo Code Redemption. If more than one (1) Qualified Entry is received on the same day from a Registration of a New PlayNow Account or a Promo Code Redemption, only the first Qualified Entry will count towards this Contest.

3. **“No-Purchase Necessary”**: Qualified Entrants may obtain one (1) Qualified Entry by mailing an entry to British Columbia Lottery Corporation, 2940 Virtual Way, Vancouver, B.C., V5M 0A6, Attention: Sports Sponsorship. The envelope must contain the entry, which must be on a single sheet of paper. The entry must contain the following information, which must be legible: **full name, mailing address with postal code, phone number and email address**. Only one (1) No-Purchase Necessary entry may be submitted per person in this Contest. Any mailing containing more than one entry, including multiple mail-ins by the same person, will be discarded, including any otherwise valid entry. Mail-in entries must be received by the close of the Contest Period in order to be eligible for the Grand Prize.

### The Prizes

- There are two (2) prizes to be won in this Contest.
- Two (2) winners (the **“Grand Prize Winners”**) will receive the grand prize: a trip for two (2) people to Toronto to watch the Vancouver Whitecaps FC vs. Toronto FC, which includes flights, accommodations, match tickets, and PlayNow free play tokens (the **“Grand Prize”**).

### The Draw

- Qualified Entries received during the Contest Period are entered into a random draw (the **“Draw”**) to select two (2) Qualified Entrants to win the Grand Prize (the **“Drawn Entrants”**).
- The Draw will be performed on July 24<sup>th</sup>, 2023 or as soon as practicable thereafter and will be conducted by two (2) BCLC employees at the BCLC office in Vancouver.
- If BCLC is unable to determine that a Drawn Entrant meets the requirements of this Contest, the Drawn Entrant will be disqualified, and another entry will be drawn. This process will continue until the Grand Prize is awarded.
- A BCLC representative will attempt to contact the Drawn Entrants via a telephone call or email, or both, within four (4) business days after the Draw.
- A maximum of three (3) attempts will be made to contact the Drawn Entrants via telephone call or email.
- The Drawn Entrants will have three (3) business days from the initial contact attempt to accept the Grand Prize. If BCLC is unable to contact a Drawn Entrant, that Drawn Entrant may be disqualified, and a new Drawn Entrant will be drawn to win the Grand Prize.
- The Drawn Entrants must provide government-issued, photographic identification acceptable to BCLC, complete such representations and indemnities as required by BCLC, and correctly answer a skill-testing question in order to receive the Grand Prize.   - Hotel Accommodations for two (2) people for two (2) nights (Dates TBC – depending on team schedule).
  - Two (2) tickets to the Toronto FC vs. Whitecaps FC match on September 16, 2023.
- \$100 PlayNow Sports Free Play Token.
