

Contest Period

This contest runs from 12:00:00 am PT on March 18, 2024 to 11:59:59 pm PT on May 12, 2024 ("Contest Period").

The Contest Period is separated into eight (8) weeks, each beginning on Monday at 12:00:00 am PT and ending on Sunday at 11:59:59 pm PT (each a "**Week**").

Qualified Entrant

- A "Qualified Entrant" is a resident of British Columbia, 19 years of age or older who is not:
 - a. a British Columbia Lottery Corporation ("BCLC") employee, or an employee, or a family and household member of the same residing at the same address of either VANCOUVER WHITECAPS FC L.P. ("VWFCLP"), Major League Soccer L.L.C. and its member teams (together, "MLS"), Soccer United Marketing, L.L.C. ("SUM"), MLS Canada ULC (MLS, SUM and MLS Canada ULC are collectively referred to as the "MLS Entities") and each of their their respective parents, governors, affiliated companies, subsidiaries, licensees, distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the contest;
 - b. an individual who is self-excluded or who self-excludes during the Contest Period from PlayNow.com or from a BCLC gaming facility; or
 - c. an individual that is barred from PlayNow.com or a BCLC gaming facility.

How to Enter the Main Prize Draw

1. A Qualified Entrant may complete one of the following to obtain one (1) "Qualified Entry" to be entered for "Main Prize Draw":

a. PlayNow Sports Bet

- i. Qualified Entrants may obtain one (1) Qualified Entry by logging in to their PlayNow.com account, correctly entering the "Promo Code": CAPS during the Contest Period on the "My Promotions" page of PlayNow.com and making cumulative \$10 wager(s) on any MLS match(es) during the Contest Period, which, for clarity, includes a parlay bet containing at least one (1) selection on any MLS game.
- ii. Qualified Entrants may obtain a maximum of ten (10) Qualified Entries each Week during the Contest Period from a PlayNow Sports Bet. Qualified Entrants may receive one (1) entry for every \$10 wagered up to a maximum of ten (10) entries from PlayNow Sports bets for each Week of the Contest Period, for a maximum of 80 Qualified Entries.


b. Set a Time Limit

i. Qualified Entrants may obtain one (1) Qualified Entry by logging in to their PlayNow.com account, navigating to "my account" and then "my budgets" and setting a daily or weekly time limit. This tool assists players in managing their time spent on PlayNow.com and encourages healthy play. Time limits must be in place when the Contest Period closes to generate a Qualified Entry.

c. No-Purchase Necessary

i. Qualified Entrants may obtain one (1) Qualified Entry each Week of the Contest Period by mailing an entry to British Columbia Lottery Corporation, 2940 Virtual Way, Vancouver, B.C., V5M 0A6, Attention: Sports Sponsorship, Whitecaps Contest. The envelope must contain the entry, which must be on a single sheet of paper. The entry must contain the following information, which must be legible: full name, mailing address with postal code, phone number and email address.

ii. Eight (8) Qualified Entries may be obtained through the no-purchase necessary entry method. Mail-in entries must be received by the close of the Contest Period to be eligible for a Prize, including the Grand Prize.

Main Prizes

- 2. There are a total of two (2) Grand Prizes to be won (the "**Grand Prize**"), and three (3) Consolation Prizes to be won (the "**Consolation Prize**").
- 3. There will be two (2) winners who will each receive one (1) Grand Prize (each a "Grand Prize Winner"). There will be three (3) winners who will receive the Consolation Prize (the "Consolation Prize Winner").
- 4. Each Grand Prize consists of two (2) Pitchside tickets to Vancouver Whitecaps FC vs Inter Miami CF on May 25, 2024 and one (1) \$100 free bet voucher to PlayNow Sports. Each Grand Prize has a total value of approximately \$1,200.
- 5. Each Consolation Prize consists of two (2) Club Seat tickets to Vancouver Whitecaps FC vs Colorado Rapids on June 1, 2024 and one (1) \$50 free bet voucher to PlayNow Sports. Each Consolation Prize has a total value of approximately \$250.
- 6. All MLS game tickets are for Vancouver Whitecaps FC home games at BC Place Stadium Vancouver, British Columbia.
- 7. Ticket section, row, and seat numbers are preassigned and cannot be selected by winners.

Main Prize Draw

- 8. Qualified Entries received during the Contest Period are eligible for a random draw ("**Draw**") consisting of two (2) Grand Prizes and three (3) Consolation Prizes during the Contest Period.
- 9. Draws will be conducted to select a Qualified Entry ("**Drawn Entry**") for each Consolation Prize and Grand Prize. Draws will be performed after the Contest Period closes, or as soon as practicable thereafter, and will be conducted by two (2) BCLC employees at the BCLC Office in Vancouver.
- 10. If BCLC is unable to determine that the Drawn Entry meets the requirements of this contest, the Drawn Entry will be disqualified and another entry will be drawn. This process will continue until the applicable Consolation Prizes or Grand Prizes are awarded.
- 11. A BCLC representative will attempt to contact all prize winners via a telephone call or email, or both, within four (4) business days after the Draw.
- 12. Winners will have three (3) business days from the initial contact attempt to accept their Prize or Grand Prize, as applicable.
- 13. Winners must provide one (1) piece of government-issued, photographic identification acceptable to BCLC, complete such representations and indemnities as required by BCLC, and correctly answer a skill-testing question in order to receive the Prize. BCLC reserves the right to disqualify any Qualified Entrant that does not complete each of these conditions.



Contest Rules

- 14. For each Prize, BCLC will draw a Qualified Entrant to win the corresponding Prize (who becomes a "**Drawn Entrant**").
- 15. A Drawn Entrant will only be eligible to win one (1) Consolation Prize or Grand Prize. A Qualified Entrant who has won a Grand Prize will not be entered into the draw for the Consolation Prizes but will be allowed to win social prizes.
- 16. All Consolation Prizes and the Grand Prize must be accepted as awarded and cannot be substituted or exchanged for cash.

- 18. To obtain a "Social Qualified Entry", a Qualified Entrant must:
 - a. Find the contest entry post for the Contest Period on PlayNow Sports' official X page (@PlayNowSports), Facebook page (@SportsAction), or Instagram page (@playnow_sports) (collectively, the "PlayNow Sports' Official Social Media Pages"); and
 - b. Interact with the contest posts on PlayNow Sports' Official Social Media Pages by commenting.
- 19. Qualified Entries must be received by the PlayNow Sports' Official Social Media Pages before the end of the Contest Period to be eligible to win a prize.
- 20. A Qualified Entrant can receive an infinite number of Qualified Entries on each of the PlayNow Sports' Official Social Media Pages during the Contest Period.
- 21. No purchase is necessary to enter Social Prizing.

Social Prizes

- 22. There are a total of eight (8) social prizes to be won (each a "Social Prize") to be awarded to a total of eight (8) winners (each a "Social Winner"). There are a total of two (2) grand social prizes (each, a "Grand Social Prize") to be awarded to a total of two (2) winners (each a "Grand Social Winner").
- 23. Each Social Prize consists of one (1) Vancouver Whitecaps shirt and one (1) \$50 PlayNow Sports free bet voucher, valued at approximately \$100.
- 24. Each Grand Social Prize consists of two (2) Club Seat tickets for Vancouver Whitecaps FC vs Inter Miami CF on May 25, 2024 and one (1) \$50 PlayNow Sports free bet voucher, valued at approximately \$250.
- 25. Each Vancouver Whitecaps shirt has a preassigned size and may not be selected or exchanged by the Social Winners.



Social Prize Draw

- 26. For the Eligibility Period, each Social Qualified Entry will be reviewed, and the winners will be selected based on a random draw by a BCLC representative.
- 27. The process to select a potential Qualified Entrant (who becomes a "Social Prize Drawn Entrant") will be completed within 48 hours after the Contest Period ends, or as soon as practicable after the end of the Contest Period by a BCLC representative. Each Social Prize Drawn Entrant is deemed to be a winner when BCLC confirms the Social Prize Drawn Entrant meets these contest conditions.
- 28. BCLC will make reasonable efforts to contact the Social Prize Drawn Entrants via Facebook direct message or Instagram direct message, depending on the original method of entry. If a Social Prize Drawn Entrant does not accept the prize within 24 hours after BCLC's first attempts to contact the Social Prize Drawn Entrant, that Social Prize Drawn Entrant will be disqualified and another Social Prize Drawn Entrant will be chosen and contacted until the Social Prize Drawn Entrant accepts the prize and is deemed a winner in accordance with these contest conditions. Each subsequent Social Prize Drawn Entrant will have 48 hours to accept the prize after BCLC first contacts the Social Prize Drawn Entrant.

BCLC will not be responsible for delivery errors or failures.




