## **Definitions**

**BCLC** means British Columbia Lottery Corporation.

**MBLL** means Manitoba Liquor and Lotteries Corporation.

**SaskGaming** means Saskatchewan Gaming Corporation.

**SIGA** means Saskatchewan Indian Gaming Authority.

**Casino Bonus** means a casino bonus that may be used to wager on Eligible Games.

**Eligible Games** means PlayNow.com casino games, excluding Live Casino, Sic Bo, Baccarat and Roulette, subject to availability.

**Held Funds** means the account where a player's winnings from a Casino Bonus with a wagering requirement in progress are held.

**Eligible Participant(s)** means:

- a British Columbia resident, 19 years of age or older with an active PlayNow.com account,
- a Saskatchewan resident, 19 years of age or older with an active PlayNow.com account,
- a Manitoba resident 18 years of age or older with an active PlayNow.com account
- provided that:
  - individuals who are currently self-excluded or who self-exclude at any time during the Promotion Period from PlayNow.com are not Eligible Participants and are not eligible to receive a Casino Bonus; and
  - individuals that are currently barred or are barred at any time during the Promotion Period from PlayNow.com, or a British Columbia, or Saskatchewan gaming facility, or a gaming facility operated by MBLL, are not Eligible Participants and are not eligible to receive a Casino Bonus.

**Promotion Period** means:

For British Columbia:

- The Promotion Period is from 00:00:00 am PDT on June 12, 2026, to 23:59:59 pm PDT on June 24, 2026.

Saskatchewan:

- The Promotion Period is from 01:00:00 am CST on June 12, 2026, to 00:59:59 am CST on June 25, 2026.

Manitoba:

- The Promotion Period is from 02:00:00 am CDT on June 12, 2026, to 01:59:59 am CDT on June 25, 2026.

**Sports Wager** means a wager placed on any sport on PlayNow.com

**Wagering Requirement** means the minimum dollar value on Eligible Games a player must spend before they are eligible to withdraw their winnings generated from Casino Bonus.

## **How to Receive a Casino Bonus**

1. To receive a Casino Bonus under this Promotion, you must complete the following steps, in the following order:

- a. Register for an account on PlayNow.com or log into your PlayNow.com account.
  - b. Enter the Promotion Code **BETCASINO** in the "My Promotions" section of PlayNow.com during the Promotion Period.
  - c. Make a single sports wager totalling \$20 or more on any sport on PlayNow.com during the Promotion Period.
  - d. Your \$20 Casino Bonus will be automatically added to your account.
2. The Promotion Code may only be redeemed once.
  3. Once credited to your account, the Casino Bonus must be used within seven (7) days. Casino Bonuses will not be reissued following expiration.
  4. The Casino Bonus awarded from this Promotion has a ten (10) times Wagering Requirement applied to them.

### Wagering Requirement Rules

- a. The Wagering Requirement for each Casino Bonus is ten (10) times the value of redeemed Casino Bonus. You will meet the Wagering Requirement when the total dollar value of wagers made with the Casino Bonus add up to ten (10) times the value of the Casino Bonus
    - i) The Wagering Requirement =  $\$20 \times 10 = \$200$  (\$20 Casino Bonus + \$180 play through of winnings). The Wagering Requirement is met when a player wagers the \$20 Casino Bonus and \$180 of winnings from that original Casino Bonus Eligible Games.
  - b. Until the Wagering Requirement is met, any winnings generated from the Casino Bonus will be deposited in your Held Funds account. Held Funds may only be used for Eligible Games and cannot be used for sports wagers or other promotions, and you cannot withdraw Held Funds from your account.
  - c. Once the Wagering Requirement is met, any Held Funds remaining will be automatically transferred to your cash balance and can be withdrawn from your account or used on any game on PlayNow.com

  8. Wagers placed using a Sports Bonus do not qualify for this promotion on PlayNow.com.
