

1. To participate in this 2026 CFL: Touchdown Bonus offer (the “**Promotion**”) you must:
 - a. be a British Columbia resident, nineteen (19) years of age or older with an active PlayNow account or;
 - b. a Saskatchewan resident, nineteen (19) years of age or older with an active PlayNow account or;
 - c. a Manitoba resident, eighteen (18) years of age or older with an active PlayNow account, who is not:
 - i. An MBLL employee,
 - d. This Promotion starts on **June 11, 2026 at 12:00:00 am PT / June 11, 2026 at 2:00:00 am CST / June 11, 2026 at 3:00:00 am CDT** and ends on **October 24, 2026 at 11:59:59 pm PT / October 25, 2026 at 1:59:59 am CST / October 25, 2026 at 2:59:59 am CDT** (the “**Promotional Period**”).

 - a. register for an account on PlayNow.com or log into your PlayNow.com account;
 - b. place a pre-match qualifying wager on Canadian Football League (CFL) **First Touchdown Scorer** market that;
 - i. is on a regular season CFL game featuring the **team designated for your province**:
 - a) **BC Lions** for participants residing in **British Columbia**.
 - b) **Winnipeg Blue Bombers** for the participants residing in **Manitoba**.
 - c) **The CFL team based in Regina**, Saskatchewan, commonly associated with green and white colours for the participants residing in **Saskatchewan**

 - ii. is \$20 or greater;

3. Receiving the Bonus Bet is dependent on touchdowns scored by the teams listed above in the game associated with your Eligible Wager.
4. A touchdown is defined as any scoring play recorded as a touchdown in the official game box score for the applicable CFL game(a "**Touchdown**").
5. You will receive increments of **\$5 in Sports Bonus Bets** for every touchdown scored by the eligible teams in the game associated with your first Eligible Wager, **up to a maximum value of \$20.**
 - a. **Example:** If the BC Lions score three (3) touchdowns and you place an Eligible Wager in BC, then you will receive one (1) \$15 Sports Bonus Bet (i.e. \$5 per Touchdown)
