

### **Contest Details**

The PlayNow Sports Grey Cup contest runs from 12:00:00 am PDT / 1:00:00am CST / 2:00:00am CDT on July 15, 2024 to 9:59:59 pm PDT /10:59:59 pm CST / 11:59:59 pm CDT on October 26, 2024 ("**Contest Period**").

This contest is sponsored by British Columbia Lottery Corporation ("**BCLC**" or the "**Sponsor**"). CFL Ventures ("**CFL**") is assisting the Sponsor in fulfilling a portion of the Grand Prize herein.

By participating in this contest you are signifying your agreement that you have read and agree to be legally bound by these Contest Conditions.

# **Qualified Entrant**

#### A "Qualified Entrant" means:

- a. a resident of British Columbia, nineteen (19) years of age or older, who is not a:
  - BCLC employee, representative, agent or their immediate family member and household member (whether related or not) residing at the same address; or
  - BCLC "Lottery Site Employee" as defined in the BCLC Retailer Policy Manual.
- b. a Manitoba resident, eighteen (18) years of age or older, who is not a:
  - Manitoba Liquor and Lotteries Corporation ("MBLL") employee, representative, or agent; or
  - immediate family member or household member (whether related or not) of an MBLL employee, representative or agent; (immediate family members is defined as father, mother, brother, sister, spouse (including common-law), child or ward of the employee; or
- c. a Saskatchewan resident, nineteen (19) years of age or older, who is not a:
  - Saskatchewan Indian Gaming Authority ("SIGA") board member, agent for SIGA, contractor for SIGA and/or an immediately family member or other persons (whether related or not) residing in the same household as those listed above.

A Qualified Entrant does not include:

- a. a participant in BCLC's Game Break Program during the Contest Period on PlayNow.com or from a BCLC gaming facility;
- an individual that is prohibited or barred from PlayNow.com or a British Columbia or Saskatchewan gaming facility, or individuals who self-exclude from a gaming facility operated by MBLL;
- c. an employee, representative or agent of CFL, its affiliates, partners and related entities (including but not limited to CFL Enterprises LP, CFL Enterprises G.P. Inc., CFL Holdings G.P. - d. any other individuals or entities involved in the development, promotion, production, implementation, administration, judging or fulfilment of the contest, and their employees, immediate family members or household members (whether related or



not).

#### How to Enter the Main Prize Draw

    - Qualified Entrants may obtain one (1) Qualified Entry by logging in to their PlayNow.com account, correctly entering the "Promo Code": GREYCUP24 during the Contest Period on the "My Promotions" page of PlayNow.com, and making a single wager that is at least \$10 on any CFL Parlay containing at least two (2) CFL games with minimum combined odds of +100 during the Contest Period, which, for clarity, includes CFL pre-game parlay wagers only and can be parlayed with other pre-game wagers from other sports. For clarity, each such wager is only eligible for one (1) Qualified Entry, regardless of if the wager amount is over the \$10 minimum. For example, a single wager of \$20 does <u>not</u> entitle a Qualified Entrant to two (2) Qualified Entries.
    - Qualified Entrants may obtain a maximum of ten (10) entries for each week of the Contest Period, correlating with the weeks of the 2024 CFL schedule (Week 7, Week 8 etc.), from PlayNow Sports CFL Betting. Qualified Entrants may obtain a maximum of 150 entries.

#### b. No-Purchase Necessary

i. Qualified Entrants may obtain one (1) Qualified Entry during the Contest Period by mailing an entry (bearing sufficient Canadian postage) to:

No-Purchase Necessary entries must be received before the close of the Contest Period to be eligible for a Consolation Prize and the Grand Prize. The Released Parties are not responsible for, and accept no liability whatsoever in relation to, any late, lost, misdirected, delayed, incomplete or incompatible No-Purchase Necessary Qualified Entries (all of which are void).
- 2. By submitting a Qualified Entry, you agree that the Qualified Entry complies with all conditions stated in these Contest Conditions.



#### Prizes

- 3. There is one (1) grand prize to be won (the "**Grand Prize**"), and ten (10) consolation prizes to be won (each the "**Consolation Prize**" and together with the Grand Prize, the "**Prizes**").
- 4. There will be one (1) winner who will receive the Grand Prize (the "Grand Prize Winner"). There will be ten (10) winners who will receive the Consolation Prize (the "Consolation Prize Winner", and together with the Grand Prize Winner, the "Winners").
- 5. The Grand Prize consists of a VIP trip to the 2024 Grey Cup in Vancouver, British Columbia and other prizes, as set out below:
  - a. two (2) Grey Cup game tickets for the game which is currently scheduled to be held at BC Place, November 17, 2024;
  - b. round-trip transportation from the Grand Prize Winner's residence to the Fairmont Waterfront in Vancouver, not to exceed a maximum of \$3,500, either (at the sole discretion of the Sponsor):
    - i. flights and car service necessary for two (2) people;
    - ii. gift cards for gas, if the Grand Prize Winner will drive to, and from, the Fairmont Waterfront; or
    - iii. gift cards for ride share, if the Grand Prize Winner would like to use car share services to, and from, the Fairmont Waterfront;

  - f. \$250 food and beverage credit at Parq Vancouver.
- 6. The Grand Prize has a total retail value of approximately CAD\$5,000.
- 7. The section, row, and seat numbers for the Grey Cup game tickets are preassigned and cannot be selected by the Grand Prize Winner.
- 8. Each Consolation Prize consists of \$250 in free bet tokens that can be used on PlayNow.com Sports, awarded to each Consolation Prize Winner as five (5) \$50 free bet tokens. Each Consolation Prize has a total retail value of approximately CAD\$250.

# Prize Draw

- 10. Qualified Entries received during the Contest Period are eligible for a random draw ("**Draw**") consisting of one (1) Grand Prize and ten (10) Consolation Prizes during the Contest Period.
- 11. Draws will be conducted to select a Qualified Entry ("Drawn Entry") for each



Consolation Prize and the Grand Prize. Draws will be performed on October 30, 2024, or as soon as practicable thereafter, and will be conducted by two (2) BCLC employees at the BCLC Office in Vancouver.

- 12. If BCLC, SIGA in conjunction with BCLC, or MBLL in conjunction with BCLC is unable to determine that the Drawn Entry meets the requirements of this contest, the Drawn Entry will be disqualified and another entry will be randomly drawn. This process will continue until the applicable Consolation Prizes and/or Grand Prize are awarded.
- 13. A BCLC representative will attempt to contact all Consolation Prize Winners and the Grand Prize Winner via a telephone call or email, or both, within four (4) business days after the Draw.
- 14. Winners will have three (3) business days from the initial contact attempt to accept their Consolation Prize or Grand Prize, as applicable.

# Prize Delivery

- 18. The Consolation Prizes will be delivered to each Winner electronically via the email address provided by the Winner.
- 19. The following portions of the Grand Prize will be delivered to the Winner electronically via the email address provided by the Winner:
  - a. Grey Cup game tickets;
  - b. Festival Passes for Grey Cup festival events;
  - c. PlayNow Sports free bets; and
  - d. food and beverage credit at Parq Vancouver.
- 20. Accommodation, flights, and transportation for the Grand Prize will be awarded to the Grand Prize Winner via email with instructions about how to book with the CFL and CFL's travel partner, Red Label Vacations Inc. (dba as RedTag). The Grand Prize Winner must contact the CFL by a time and date specified by a BCLC representative. All travel arrangements, accommodations, scheduled events and other aspects of the Grand Prize itinerary will be arranged by BCLC and/or CFL in its sole and absolute discretion. Once the travel itinerary has been finalized between the Grand Prize



Winner and BCLC and/or CFL as applicable, no changes can be made unless initiated or approved by BCLC and/or CFL, as applicable. Changes to flights and/or passenger names are not accepted once bookings have been confirmed.

### **Contest Winner Rules**

- 23. For each Prize, BCLC will draw a Qualified Entrant to win the corresponding Prize (who becomes a "**Drawn Entrant**").
- 24. A Drawn Entrant will only be eligible to win a maximum of one (1) Consolation Prize or Grand Prize. A Qualified Entrant who has won a Grand Prize will not be entered into the draw for the Consolation Prizes.
