

Definitions

“**BCLC**” means British Columbia Lottery Corporation.

“**MBLL**” means Manitoba Liquor and Lotteries Corporation.

“**SIGA**” means Saskatchewan Indian Gaming Authority.

“**SaskGaming**” means Saskatchewan Gaming Corporation.

“**Drawn Entrant**” means an individual whose name is drawn to win a Prize as a result of the Prize Draw.

“**Prize Winner(s)**” means the Drawn Entrant or Reserve Drawn Entrant who fulfills these Contest Conditions.

“**Reserve Drawn Entrant**” means an individual whose name is drawn as a backup as a result of the Prize Draw and who becomes a Qualified Entrant in the event that the original Drawn Entrant becomes disqualified.

“**Eligible Games**” means any sports wager on PlayNow.com.

Contest Period

1. This contest (the “**Contest**”) runs from:
 - a. Saskatchewan (CST): From 1:00:00 AM CST on September 15, 2025, to 12:59:59 AM CST on October 20, 2025.
 - b. Manitoba (CDT): From 2:00:00 AM CDT on September 15, 2025, to 1:59:59 AM CDT on October 20, 2025.

Qualified Entrant

2. A qualified entrant (“**Qualified Entrant**”) means:
 - b) a Saskatchewan resident, nineteen (19) years of age or older with an active PlayNow.com account or;
 - b) a Manitoba resident eighteen (18) years of age or older with an active PlayNow.com account, who is not:
 - a MBLL employee.provided that:
 - individuals who are currently self-excluded or who self-exclude at any time during the Contest Period from PlayNow.com are not Qualified Entrants and are not eligible to win a Prize; and
 - individuals that are currently barred or are barred at any time during the Contest Period from PlayNow.com, or a British Columbia, or Saskatchewan gaming facility, or individuals who are self-excluded from a gaming facility operated by MBLL, at any time during the Contest Period are not Qualified Entrants and are not eligible to win a Prize; and
 - individuals who are employees, representatives, or agents of the Canadian Football League, its affiliates, partners, and related entities (including but not limited to CFL Enterprises LP, CFL Enterprises G.P. How to Enter

3. There are two (2) ways to enter this Contest:
 - a. Obtain a "Qualified Entry" through PlayNow.com; and/ or
 - b. Submit a No Purchase Necessary Entry.

Qualified Entry

4. **On PlayNow.com:**
 - Qualified Entrant must sign up or log in to their PlayNow.com account and successfully enter the correct promotion code, **GREYCUP2025**, for their province (the "**Promotion Code**") during the Contest Period into the MyPromotions section of their PlayNow.com account.
 - Make a minimum of \$5 wager on any Eligible Games during the Contest Period. Wagers must be placed using funds from the Cash Balance. Wagers made with Casino Bonus, Tokens, or other promotional credits do not qualify.
 - Qualified Entrants may receive a maximum of one (1) Qualified Entry per day during the Contest Period.
 - Qualified Entrants may receive a maximum of thirty-five (35) Qualified Entries through PlayNow.com into this Contest.

Bonus Entries

5. Qualified entrants may enter additional promotional codes to be provided via email or social media communications into the MyPromotions section of their PlayNow. Each additional promo code entered counts as one (1) additional entry, for a maximum of two (2) bonus entries into the contest.

No Purchase Necessary Entry

6. "**No Purchase Necessary Mail-In**" means
 - No purchase is necessary to enter this contest. To obtain a No Purchase Necessary Entry, a Qualified Entrant may obtain five (5) Qualified Entries by mailing an entry to British Columbia Lottery Corporation, 2940 Virtual Way, Vancouver, B.C., V5M 0A6, **Attention: Promotions, Grey Cup Giveaway**. The envelope must contain the entry, which must be on a single sheet of paper. The entry must contain the following information, which must be legible: full name, mailing address with postal code, phone number, and email address, and PlayNow account email or username. An entry will be disqualified if it is missing any of the details mentioned above. Mail-in entries must be received by the end of the Contest Period to be eligible. Mail-in entries received after the end of the Contest Period will be disqualified and not entered into the draw.
 - Each Qualified Entrant may submit a maximum of one (1) No Purchase Necessary Entry.

The Prizes

 - The Manitoba Prize includes:
 - Two (2) Grey Cup Festival Passes, including access to the Coors Light concert series (line up has not been announced), value \$99 each.
 - Two (2) premium-level tickets to the CFL Grey Cup game in Winnipeg, Manitoba on Sunday, November 16, 2025, valued at \$384.96 each.
 - b) In Saskatchewan, there is one (1) Prize available to be won, with a value of up to approximately \$2,800 CAD.
 - The Saskatchewan Prize includes:

- Two (2) Grey Cup Festival Passes, including access to the Coors Light Concert Series, value \$99 each
 - Two (2) tickets to the CFL Grey Cup game at the Skyview Zone in Winnipeg, Manitoba on Sunday, November 16, 2025, valued at \$298 each.
 - Travel Credit valued at \$1,000 CAD to be deposited into Winner's PlayNow Account.
 - Three (3) nights' accommodation at Canad Inns Club Regent in Winnipeg, Manitoba, in a room with two (2) Queen beds for two (2) adults.
 - *Check-in on November 14, 2025, and check-out on November 17, 2025. Accommodation is valued at approximately \$1,000 CAD. Only room and applicable taxes are covered; the Winner is responsible for all incidental charges and must provide a valid credit card upon check-in for a damage deposit.*

The Draw

13. Qualified Entries received with respect to each province during the Contest Period are entered into a random draw for that province (the "**Prize Draw**") to select one (1) Qualified Entrants and five (5) backups in Manitoba, and one (1) Qualified Entrants and five (5) backups in Saskatchewan to win a Prize (the "**Drawn Entrants**"). The Prize Draw will occur on October 23, 2025, or as soon as practical thereafter.
14. A representative from MBLL will attempt to contact the Drawn Entrant selected for the Manitoba Prize in conjunction with BCLC, and a representative from BCLC will attempt to contact the Drawn Entrant selected for the Saskatchewan Prize, by telephone and/or email using the contact information provided in their PlayNow.com profile within two (2) days of the Prize Draw.
